

“Kybernion,” “the Steering Paddle”

Explanation: The realization that our “New Learning” Language Analysis Methodology would solve the Problem of the BYU Machine Translation Project of the 1970’s, of not being able to find a way to develop Cost-effective Machine Translation, began in June of 1977. A little over a year later it was written up in the Wall Street Journal as having accomplished that.

Then, after the large, International News Conference, held in November, 1978, in New York City, that followed our successful Introduction of Machine Translation to the World Translation Industry, at the Annual Convention of the American Translators Association, that was held that year in New York City, the World Press announced the success of our achievement internationally.

Not long thereafter it became apparent that the responsibility was on us to produce the Fully Automatic Machine Translation that Church Presidents had prophesied would follow the Development, by Church Members, of Cost-effective Machine Translation. During the Preparations preceding that New York City Demonstration the procedure became well understood of how to improve our New Learning Product of Cost-effective Machine Translation, in order for it to function at the Fully Automatic level. The Challenge, that came with this Understanding, was, “How to communicate this to the Thousands of Foreign Language Translators etc. needed in order to improve Cost-effective Machine Translation in order for it to be developed into Fully Automatic Machine Translation, as the Presidents of the Church had prophesied would happen?”

“The 1,000-page Course” was developed, over these intervening years, as the way to introduce the Linguists, Programmers, Business Leaders, etc. – who are needed to produce the Products that the Utility will need in order for it to be able to begin its operations and, then, to be able to continue those operations – to the “Conditions” under which the Worldwide Interlingual Telecommunications Utility will need to be able to function, for all Languages, all over the World, as the Church Presidents prophesied that it will operate, on this Development of Fully Automatic Machine Translation.

After the Course was completed it seemed that it would help if an “Introduction” was written for it, to indicate relevances for Conditions in the USA at this time. That Introduction is entitled, “The Story of Rights in America.”

Right now, though, it seems that there need to be some synopses made, from certain things addressed in the 1,000-page Course, to assist those who go through the Course, in order for them to be able to “briefly” explain to people certain of the Issues that the Course addresses.

One of these Issues is, “the Enemy”: that which is characterized as being, “the Enemy” in the Holy Scriptures and which is referred to as being that “Enemy” of Goodness by Believers in the Holy Scriptures.

One of the Scriptural designations for this Enemy is “Babylon,” as in, “Babylon the Great is fallen.” Another is, “the Antichrist.” Another is, “the Mother of Harlots and Abominations of the Earth, Revelation 17:5”

It is fairly easy to get specific about “Babylon.” That name is only the Middle Eastern name, “Babel” (as in, “the Tower of Babel”), as that name was used and pronounced among its subsequent Greek Conquerors. It is well known how the Greek suffix, “-on,” is attached in many Greek expressions, such as in: “neutr-on,” “prot-on,” etc. So, the name, “Babyl-on,” is just the Middle Eastern name, “Babel,” with the Greek suffix, “-on” attached to it. In the Middle Eastern Language that is spoken where the City of Babylon used to be located, the name of that City is still pronounced: “Bab-eel.” Therefore, it is quite easy to see how its Greek Conquerors would have devised for it a pronunciation that produced a spelling, down through History, close to: “Bab-eel-on.”

The “Tower of Babel” was thought of as “the Enemy of all Righteousness” by the Prophetic Leaders of the Holy Scriptures. The “Second Father” of the Human Race, Noah, and his Patriarchal Successor Son, Shem, had to flee for their lives from the Evils of the Builders of the Tower of Babel. However, the Tower of Babel’s way of doing things came down to the followers of its Evil Builders in a “whole different light.”

In the original ancient Language that remained in that area, the expression, “Bab-el” means, “the Tower (Bab) of God (El).” Readers of the Bible know that the names, “El-ohim” and “El-i” are names used in the Bible for God the Father.

Moreover, the Middle Eastern word for that Tower has also retained a significance. All Americans know the tale of “Ali Baba.” The current Middle Eastern word for “God” is “Allah.” The word “Allah” becomes “Ali,” to mean, “of God.” In the Middle East the expression, “Baba Ali,” has always meant, “The Tower of God.”

So, whereas to Christian readers of the Bible the “Tower of Babel” has always been a part of, “the quintessence of Evil,” to the people of the Middle East it has always meant the origin of their Social Culture.

It may be the first time that this information is heard by many modern, Christian Americans; but, until the end of World War I, the “Pope” of the Mohammedan Religion bore the name of “the Tower of God”; he was the, “Baba Ali.” (And, of course, that is just “Ali Baba” said backwards.)

Many modern Americans may have never been informed of the fact that Mohammedans were led by a “Pope,” down to the end of World War I. Some may have been informed of the fact that he was also the Emperor of the Middle Eastern Empire that

was named, “the Ottoman Empire.” He was on the losing side of World War I, so his Office went out of existence at that time.

Some Americans may know that the English word, “Pope” comes from the French word that is spelled, “Pape.” However, in France that word is pronounced quite a lot like the Italian pronunciation for their word, “Papa,” which is the word for, “Pope,” in Italy. However, the word and concept of a “Papa” did not originate in Italy.

That word and its meaning came to Italy from Ancient Greece. Some people may be familiar with such Greek names as, “Papanicholas” and “Papandropolis.” This word, “Papa,” its pronunciation, meaning and the function that it represented, all came to Italy from Ancient Greece.

However, the name and the significance of the name, “Papa” did not originate in Greece. It came to Ancient Greece from the Middle Eastern Language of Arabic, spoken, anciently, to the east of Greece. Throughout the history of the use of this word in Italy, all Arabic-speaking Roman Catholics have always referred to, “the Pope” as, “the Baba.” The origin of the word and the concept of that word as the name for the Leader of Cultures of the Eastern Mediterranean area, is the Arabic concept of that word, as expressed in the name of the Leader of the Mohammedan Religion down to World War I, who was, again, thought of as “the Baba Ali.” That name also served as the widely known name for his Headquarters.

A good beginning point to orient people to the concept of, “the Enemy,” as understood in the expression, “Babylon the Great is fallen,” is the Revelation that the Prophet Daniel explained to Nebuchadnezzar, the King of Babylon.

His “Neo-Babylonian Empire” was operating around the time of 600 BC and was headquartered at the site of the Tower of Babel. That, “King,” Nebuchadnezzar, was the Conqueror/Dictator who ruled much of the Middle East from that location.

He had had a nightmare, that the Prophet Daniel explained for him. He had seen a Great Image, with a head of Gold, breast and arms of Silver, belly and thighs of Brass, legs of Iron, and feet of Iron mixed with Miry Clay. He saw that a “Stone was cut out of the mountain without hands” that rolled down to hit the Great Image in the feet and break it into little pieces that were then blown away to be gone, thereafter, forever, Daniel 2:45.

The Prophet Daniel told Nebuchadnezzar that the Image was the “kingdoms” that would be ruling then and in the future. His kingdom, of the Neo-Babylonian Empire, was the head of Gold. That was conquered by the Persian Empire, which was the breast and arms of Silver. That was conquered by the Ancient Greek Empire, which was the belly and thighs of Brass. That was replaced by the Ancient Roman Empire, the legs of Iron. And, when that went away, it was succeeded by the Governments (Empires, Kingdoms etc.) of Medieval and Modern Europe etc., the feet of Iron mixed with Miry Clay.

A point to be made about this Great Image and what it was made of is that it was in the days of that Neo-Babylonian Empire, the “head of Gold,” that the practice was begun of using the gold ore deposits of the Middle East to make the “Gold Coins” which came to constitute the concept of “Money.” Indeed, these Organizations, referred to above, are the Organizations that gave to the World the concept of “Money,” as the way that those Governments based their Operations upon “Gold Coin Money.” It is interesting that these Governments, that succeeded the Government of the Neo-Babylonian Empire, in being the Organizations that spread to the World the Concept of operating on Coins of different types, which types were those made of the progressively baser metals, that were, basically, “change” for Gold Coins, would be characterized, as their parts of the Great Image, as the metals that were, successively, more and more “base” than gold.

That Great Image is indeed, the “Babylon the Great” that “is fallen,” of that Scriptural Expression. And, it was, in fact, the vast gold ore deposits that were located in the ancient country of Lydia, in westernmost Asia Minor, just to the west of the Neo-Babylonian Empire, in an area that was subservient to it, from which vast deposits the “idea” of Gold Coin Money was invented, to serve as the basis upon which “Governments” would operate, in the tradition of the operations of the Government of the Neo-Babylonian Empire. So, these “Governments” that succeeded the Government of the Neo-Babylonian Empire, which followed it in establishing throughout the World its practice of basing its Operations on Gold Coin Money, are, at one time, along with it:

1. the parts of the “Great Image,” which makes them into
2. their, respective, parts, of “Babylon the Great,” that “is fallen,” and
3. the Succession of the Governments that established throughout the World the practice of Governments operating on Gold Coin Money.

This then brings up the Question: “Are these ‘Governments’ then ‘the Enemy,’ that is spoken of in the Scriptures as, ‘the Enemy of all Righteousness’?”

Let’s talk about them and see.

Of course the Neo-Babylonian Empire could have been expected to have had a bad reputation among the Prophets of the Old Testament, being as it was a Conqueror of a part of the Holy Land and Enslaver of its People.

The Persian Empire, that succeeded it, seems to have had a, perhaps, predictable experience as a Conquering Empire. It conquered the Neo-Babylonian Empire and then extended its rule over the Middle East, from Greece to India and from below Egypt up into what was the Soviet Union. It was run by One Military Dictator who commanded All Military Personnel in that Area and ruled that Area absolutely. However, at the western limit of his rule he was confronted with a Challenge.

At that western limit of his rule were numbers of settlements of People who spoke the Greek Language. They lived on a variety of Islands and Peninsulas, in quite a variety of tiny Countries. They dominated those Waters of the Aegean Sea and, from there, the

Trade of the entire Northern Shore of the Mediterranean Sea. They were protected from the otherwise all-conquering Army of the Persian Empire by the Waters surrounding their Islands etc. and by the fact that if the Persians tried make an amphibious attack, over the Water, to attack the people on one of those Greek-speaking Islands, all of the “Naval Resources,” from all of the other Greek-speaking Islands, as well from all of their Sea Ports which they operated along the entire North Coast of the Mediterranean Sea, could rush to the defense of the people on that particular Island and easily defeat any attempt of the Persian Army to attack such an Island. “An Army can’t fight a Navy!”

And, so, a stalemate resulted in the Eastern Mediterranean, for about the succeeding Two Centuries, after the commencement of the Persian Empire, between these two Forces: the World’s Biggest Army, of the Persian Empire, and “the World’s Biggest Navy,” made up of all of the personnel from all of those many Greek-speaking Islands, Peninsulas etc., who made their Livings from the many Sea-going occupations of the people of that Area, who controlled the Sea-going Commerce, from that Area, of the North Shore of the Mediterranean Sea..

Then, as told in great detail in first few texts of the 1,000-page Course, the Greek-speaking People finally wanted to find some way to end the drain on themselves that it took to defend themselves during that 200+-year Stalemate. There developed a demand to figure out some way to “create an Army.” The Question now arises: “Is this concept of ‘Creating an Army’ that which made these Governments into ‘the Enemy of all Righteousness’?” That Question can be borne in mind as we examine the procedures that were taken by Ancient Greece to do that and by the Governments that succeeded it.

Of course it is known today that the Positions that the Ancient Greeks utilized as the Foundation upon which they organized their “conquering” Army are the products of the Absolute Ignorance of Realities of a Primitive Ancient People, which Positions the relatively more informed minds of Modern People would hold to be Absolute Insanities should they encounter such Ignorance offered today, as opposed as it is to current understandings of Reality.

This “Absolute Ignorance” is covered in a lot of detail in the 1,000-page Course, but let us review a bit of it.

A most ignorant person told the ancient Greek-speaking People that he had stayed up all night, one night, and saw that all of the Stars of the Southern Heavens “rise in the east and then go over and set in the west.” He asserted, therefore, that all Existence operates in what he designated as, “the One-Spin.” The way, that this Ancient Absolute Ignorance of Reality – as to what is happening in the Sky, as one watches it at night or during the day, as the Sun, the Moon and the Stars SEEM to revolve around the Earth every day – that was thought of as the “One-Spin,” by an ancient ignorant People, was expressed, in the Language of the “disciples” of the Greek-speaking Navy’s control over the maritime affairs of the Italian Peninsula, so that it came out in Ancient Italian as: “One-Spin” = “Uni-Verse.” [In Ancient Italian “One” is “Uni” and “Spin” is “Verse.”]

So, this Absolute, Ancient Ignorance, of guessing that “ALL OF THE HEAVENS REVOLVE AROUND THIS PLANET, EVERY DAY” – that today would be thought of as an insanely ignorant guess at absolute odds with what everybody knows is the way that things really are – which the Ancient Greeks thought of as, “the One-Spin,” was exactly translated into Ancient Italian and survives, till this day, as the Ancient Italian way of expressing the Concept of a “One-Spin,” which is, “the Uni-Verse.”

This is a “Horrible Absolute Ignorance Heirloom” from ancient “Governments.”

The next step that that Most Ignorant Person took was the assertion that the “Power” that makes the Sky “spin” around the Earth, every Day and Night, is a “Brainless, Body-less Fool” of a Greek “Theos,” that is in charge of everything. His next assertion was that the only way that this Brainless, Body-less Fool of a Greek Theos, that makes the Sky spin around the Earth, has anything to do with People on the Earth is through the medium of “the One-Spin-al Man,” the only man on the Earth through whom that Brainless, Body-less Fool of a Greek Theos will communicate with Men on the Earth.

This Most Ignorant Person then asserted that this One-Spin-al Man, who was ready to lead the Greek-speaking People to form themselves into an Army, was this Person’s disciple. He asserted that the way that the Brainless, Body-less Fool of a Greek Theos communicates with Men, through the One-Spin-al Man, his disciple, is by giving him “Correct Hunches,” “Ortho-Doxy,” in Ancient Greek. With these Correct Hunches this One-Spin-al Man, “the Universal Connection” between Men on Earth and the Theos that makes the Sky Spin around the Earth every Day and Night, can mint enough Gold Coins to pay Greek-speaking Men to transition from being Sea Farers and form themselves into an Army big enough to beat the Persian Army.

The people of Ancient Greece decided to give that a chance, and that is the way that their Army beat the Persian Army and they became the belly of Brass that took over from the breast of Silver in the Great Image. [That Person’s invention of the ancient Greek word for “One-Spin-al,” as that referred to his disciple, whom he said was “the One-Spin-al Man,” was the origin of the word, “Catholic.” In this context this word has nothing at all to do with Christianity nor the Bible. It is only the assertion of that Person as to the connection of his disciple to the Power that makes the Sky spin around the Earth every Day and Night, as given in his Ancient Greek Treatise: “ta Metaphysica,” see the beginning of “The History of School,” the first part of “The 1,000-page Course.”]

[Perhaps those who are “distanced” enough from the workings of primitive Societies to be “objective” about them might say that it seems that individuals who may seem successful enough, in relation to the concepts that “run” such primitive Societies, that they are accorded leadership positions in those Societies, are then given the opportunities to try to perform those leadership functions. Then, among those who may seem to perform those functions acceptably there may come up what the “distanced,” “objective” person might think of as what may seem to primitive societies to be the

“magic” that individuals in such primitive Societies seem to feel allows that accepted leader the “authority” “to take human life.”

It seems as though this “magic” is what the Most Ignorant Person, of whom we speak, tries to introduce as he introduces the thought that his disciple can be the “One-spin-al Man” who can form Greek Sea Farers into an Army that can beat the Persian Empire’s Army.

If one thinks of the “Enemy,” “Competitors,” of the Sea-going Commerce of the Greek-speaking People that allowed the Greeks to dominate the Sea-going Commerce of the North Coast of the Mediterranean Sea, as not merely the Persians, who, at that time, dominated that Sea-going Commerce of the South Coast of the Mediterranean Sea, but also the Babylonians, before them, and the Egyptians before them, that brings up the subject of the Phoenician People of the Sea Ports of Tyre, Sidon etc. (in what is today Lebanon), who performed the Sea-faring Services for those Entities. Those Phoenicians were so successful in doing that, as the chief Enemies, Competitors of the Greeks for dominating the Sea-faring Commerce of the Mediterranean Sea, that those Phoenicians had established and operated Phoenician Carthage, as their operation to control the Western Mediterranean Sea and numbers of locations there.

This “Magic” of the superstition of a Primitive Society, of the person who had taken over the leadership of that Society having the Authority to take Human Life, was unleashed when the Greek Army, in the process of conquering the Persians’ Empire, conquered Tyre, that Sea Port that was the historical Archenemy and Rival of the Greeks for the control of the Commerce of the Mediterranean Sea.

This unleashing had the Greeks allow their leader, that Most Ignorant Person’s disciple, to murder every man in Tyre and sell every one of the women and children of Tyre to be Slaves. Thereafter, among those Victims, that leader of those Greeks was always thought of as, “Alexander the Great Murderer of all of our Husbands, Fathers, Uncles and so many of our Sons, Brothers, Cousins, Nephews etc.”]

And, there is more, as relates to Medieval European Governments.

[The “Rules” for how this “System” that that Most Ignorant Person proposed, as the way that his Plan operates, in addition to the fact that they are known as the quintessence of Evil by every person who has heard anything of the History of Medieval Europe, are also known of by every child, who has ever heard any of the stories of the horrible ignorances of Medieval Europe, as being the Evil in so many of the tales of the Terrible Enemy that seemed that it was always against the people who were trying to do what was good, in Medieval Europe.

This “System,” as it was continued in Medieval Europe, was that only the One-spin-al Man – the Dictator over the Army of a Medieval European Country – got “Correct Hunches,” or “Ortho-dox,” in Ancient Greek, from the Brainless, Bodyless Fool of a Greek Theos that made the Sky spin around the Earth every Day and Night.

If people “believed” in the “One-spin-al,” “Orthodox” Dictator’s “Orthodoxy,” then they were also considered to be “Orthodox” or Correct Hunch People.

However, if they did not believe in the “Correct Hunches” of the One-spin-al Dictator then they were considered to be “hetero-dox.” “Heterodox,” in Ancient Greek meant, “False Hunches,” the False Hunches of the “Heretics,” “the False Hunch People,” who were opposed to the “Correct Hunches” of the “Orthodox” Dictator.

Just as it was that the two words, “Ortho” and “doxy” were combined to become the Ancient Greek word, “Orthodoxy,” so the two words, “Hetero” and “doxy” were combined to become the word and the concept of “Heresy,”

And, as so many little children know, who know of the sad tales of Medieval Europe, the people there who would not believe in and obey the “Ortho-dox,” Correct Hunches dictates of the Orthodox Dictators of Medieval Europe, were accused of adhering to “Heresy.” And, since Heresy was a Capital Crime in Medieval Europe, immediately punishable by Instant Death Sentences from and at the hands of the Agents of the Dictator who claimed that he was getting his Correct Hunches from the Brainless, Bodyless Fool of an Ancient Greek Theos – like that Correct Hunch that that Brainless, Bodyless Fool of an Ancient Greek Theos really is what it is that is making the Sun, the Moon and all of the Stars “Spin” around the Earth every Day and Night – that is the horrifying Tragedy and Sadness that is behind so much of the History of Medieval Europe, that virtually all of us have heard of since we were little children.]

That Most Ignorant Person had needed to communicate with the Men who controlled the Greek-speaking Navy, that controlled the Commerce of the North Shore of the Mediterranean Sea, with something with which they would identify. The part of Sea-going Vessels that directs the way that they go is, “the Steering Paddle.” This Person asserted to these Men, who had operated the Commerce of the North Shore of the Mediterranean Sea for Centuries, that his disciple, the One-Spin-al Man, will be able to be “the Steering Paddle” that directs them to their Goal of ending the expensive and dangerous 200+-years Stalemate with that Army of the Persian Empire. This Person asserted that with the Correct Hunches that this One-Spin-al Man gets from the Brainless, Body-less Fool of a Greek Theos, who makes the Sky Spin around the Earth every Day and Night, this One-Spin-al Man will be able to mint enough Gold Coins to pay these Greek Sea Farers to become a more effective Army than the Persian Empire had. A large part of the Commerce that these Greek Sea Farers controlled was transporting Gold Coins to Italy and to Western Europe from Greece and Asia Minor. They accepted the concept that this One-Spin-al Man would be “the Steering Paddle” that would mint enough Gold Coins to pay them to become the Soldiers whom he would “steer” to their objective of becoming a Greek Army that will beat the Persian Empire’s Army. They adopted the Greek word for a “Steering Paddle” as the expression of the way that these Sea-going Men would now be organized into an Army to accomplish their Goal. Their Greek concept and word of a “Steering Paddle” has endured till this day for what they did.

Their Greek word for a “Steering Paddle” was a “Kybernion.” The One-Spin-al Man and his “Ortho-doxy” Correct Hunches, to mint Gold Coins and pay them as he led them to their Victory, was to be their Kybernion to take them to that Objective.

Later, when the people of Rome decided to become an Empire, and imitate those activities of those Greek Sea Farers, become paid Soldiers, they used that Greek word for their doing that, which let them become the legs of Iron of the Great Image, that took over after the belly of Brass. The Romans’ word for their “Kybernion” was “Gubernum.”

When their ancient legs of Iron were replaced by the first of the Governments of Medieval Europe, the first of the Iron mixed with Miry Clay Governments, the Frankish Empire of about 800 AD, those Franks copied the Roman Empire’s word, “Gubernum,” with their French word for all succeeding Governments of Europeans, which is the, originally, French word, “Government.”

The Romans’ Empire

This is “the legs of Iron” of the Great Image, of the Governments that would descend from Babylon the Great, that would all disappear when the God of Heaven cut the Stone out of the Mountain, without hands, and destroyed all of the parts of the Great Image of Babylon and the Governments that would descend from it, forever.

So, “the Government” that originated from the settlement of people, which became named, “Rome,” would expand to become “the Empire” that grew to take in much of what had been the Greek Empire. Again, in the Great Image, this Empire became the “legs of Iron,” which Empire grew – to continue the Babylonian Tradition of a “Government” that operated on Gold Coin Money – to take over Control of things, through Gold Coin Money, from the belly of Brass of the Great Image.

So, the rulers of Rome thought of themselves as a “Gubernum” that was to follow the procedure established by the “Kybernion” of the Greeks. It might seem obvious why the Greeks decided to listen to the Most Ignorant Person’s thought that his disciple would be the “Kybernion” who would be “the Steering Paddle” who was able to take the Correct Hunches, that he got from the Brainless, Body-less Fool of a Greek Theos, who makes the Sky “Spin” around the Earth every Day and Night, and use those Correct Hunches to mint enough Gold Coins to be the Money to train enough Greek Sea Farers to become the Soldiers of a Greek Army that would be able to defeat the Persian Empire’s Army. Greek Sea Farers understood that a “Kybernion,” a “Steering Paddle,” is what it is that “controls” their Vessel as that “Kybernion” steers them to their destination. So, as these Greek-speaking Sea Farers accepted the Most Ignorant Person’s suggestion that they accept his disciple to be their Military Dictator, to pay all of them with Gold Coins to be his Soldiers, to “steer” them to their sought-for Military Victory over the Persian Army, this Military Dictator, along with his Organization was thought to be their “Kybernion,” their Gold-Coin-operated “Government,” able to “steer” them to their Destination.

“Gubernum” was about as close as the Language of the Ancient Romans could get to the sound of the Greek word, “Kybernion.” And, the Romans, seeking to follow the Greeks, decided to call the Organization that exercised Control over them, through its Gold Coins, their “Gubernum,” their “Kybernion.”

It is fairly easy to see why people who had spent their Careers as Sea Farers might call their new Military Dictator, who was going to pay them with enough Gold Coins to reach their sought-for Military Victory, their “Kybernion,” their “Steering Paddle.” “However, what was it that the people of the early settlement of Rome were doing to earn their livings, so that what they felt that their way of saying the Greek word for ‘a Steering Paddle’ was, could get them, doing that, to the Objective they sought to reach?” The Sea Farers of Ancient Greece spent their time “steering” themselves to get to the “objectives” of their Sea-faring Occupations. “What were the Objectives of the Labors of the People of Ancient Rome?” We know that those Objectives did not have much to do with Sea-faring, as the commercial activities of Sea-faring Occupations along the Shores of the Italian Peninsula, at that time, were dominated by Greek Speakers. “Well then, again, what were the Objectives of the Labors of the People of Ancient Rome, for which they established their ‘Gubernum,’ their ‘Kybernion’ to ‘steer’ them to those Objectives?”

The Settlement that became Rome was established by a person whose name was used as the name for the City. His name was, “Rom-ulus.” He was a disreputable person who had murdered his own Twin Brother. Things pertaining to the Settlement of Rome were said to be “Roman.” And, the people of that Settlement were known as “Romans.” The principal Objectives of the Labor of the “Romans” was what was named, by other people, who used to travel through the location of Rome, as, “Romance.”

“How did that come to be?”

It developed as the “Traffic” in Gold Coins developed.

Once again, the concept of operating on “Gold Coin Money” began at the time of the ancient Neo-Babylonian Empire and functioned, in large part, on the vast Gold Deposits of a small Country called, “Lydia,” to the immediate west of that Empire and subservient to it, that was located on the Aegean Sea Coast of Asia Minor. Anciently, there had never been found any Gold Deposits in Western Europe. There were different ways that the Populations of Western Europe could obtain Gold Coin Money if they wanted it. They could go to what is today the South Shore of France and exchange their Goods and Products there with the Greek Sea Farers there who had transported those Gold Coins there from their part of the World. However, they paid a higher price for doing that there than at another location.

There is a “Road” that leads from Western Europe, across the Mediterranean Sea, to the vicinity of the Islands etc. of Greek Speakers who had Gold Coins available closer to the price that they had paid for them than was available from those who controlled Sea-faring Traffic between Asia Minor and the South Shore of France. That “Road” is

the Italian Peninsula. There is a Mountain Range that extends down much of the length of Italy and a River that flows, from north to south, along the west side of that Mountain Range. And, there was a serviceable Road along the west bank of that River, down to the location where the River turned west to empty into the Sea. West of that turning place the terrain became more flat and the River broader. However, where the River started to broaden and be more difficult to cross, there was an Island in the River. People could more easily cross the small part of the River to get to that Island and then cross the other part of it to get to the land beyond it to continue their trips south toward “the ‘Heel’ of the Boot,” of the Italian Peninsula, which is the part of the Italian Peninsula that is closest to Greece, where they could exchange their Goods and Products for, first, the Commodities of the Orient that the Greeks brought there and, then, when Gold Coinage was begun, for the Gold Coins of the Greek-speaking Sea Farers, at the best price for doing so.

Just to the south and east of that Island are Seven Hills, those Hills where the City of Rome was subsequently built. Romulus lived in a hut, on the top of the Hill that is closest to that Island, from which he could look down on the Island’s traffic. He got the idea of building “bridges” over the River, on both sides of that Island, and charging the “merchants” that crossed it a “toll” for using it and taking advantage of the convenience that it afforded. That is the beginning of the “settlement” that came to bear the name, “Rome” and the reason that The Main Leader of the City of Rome would, thereafter, be designated, “The Main Bridge Fixer,” which is, “The Pontifex Maximus,” in the Language of the Romans. The English word, “pontoon,” meaning a type of a “bridge,” comes from that ancient Roman word for “bridge” in the expression, “pontifex.”

In the middle of the Seven Hills of Rome there is a rather large, flat place, shaped something like an elongated triangle. It was “outside,” from the Hills where the Settlers of the Settlements had their dwellings, so they called it, “the Outside.” The Roman word for “outside,” is the expression, “for-.” That is used in English words like, “for-eign,” meaning, “outside of one’s Country,” in the word, “for-est,” meaning, “the Trees that are growing outside of a community,” etc. That large, “outside” place was, “the For-um.”

Romulus and his followers built their bridge, from the north bank of the River to the Island and from the Island to its south bank, so that there was a road, over the River and the Island. They then built a road around the north Hill of the Seven Hills, “the Capitoline Hill,” and into the flat area of the Forum where the Merchants’ Cargoes were inspected to see what Toll was expected, which, as this history developed, was paid in Gold Coins.

After they paid their Toll, there was an Archway under which they passed, at the south apex of the Forum’s triangle. Passing under that Archway indicated that they had now paid their Toll and were at liberty to continue their Journey south, along the Road that was called, “the Appian Way,” to their Destinations at the southeast coastline of the Italian Peninsula, where they could get the best price, in Gold Coins, for their Goods and Products. This Archway, exit from the “Forum,” which exit could be thought of as a “Toll Booth,” was called, “the Fornix.”

So, Rome soon began to exploit the Babylonian Gold Coin Money Trade, as it grew to become dominant, in the Trade of Europe through Greece with the Orient, which Trade was conducted by the Merchants of Western Europe, using the Road down the Italian Peninsula, to get the best price for their Goods and Products from the Greek-speaking Sea Farers who, early on, had Gold Coins etc. for the lowest prices at locations on the southeast Coast of Italy.

A Bridge Toll was one thing to extract Gold Coins from these Merchants. However, the Leaders of Rome came up with a way to get many times that amount of Gold Coins from them, which became the principal activity for extracting Gold Coins from those traveling West European Merchants. They built a huge Building just below the Fornix Archway exit from the Forum, on the west side of the Appian Way.

It offered Hotel Accommodations. It advertised that it had the most luxurious, comfortable Hotel Accommodations with the finest Food in Italy etc. Those using those Accommodations were told that they would hear the finest Music there, in Accommodations decorated with the finest Artwork. Apparently everything that could be done to attract those Gold Coin Merchants to pay their Gold Coins to stay there was done. Apparently to get the point across that now, that they had paid their Toll and had been allowed to exit from the Forum under the Fornix Archway, and were now at liberty to continue on and to do what they pleased, this Huge Building with all of its Accommodations was also named, “the Fornix.”

Apparently one of the main things that was done to attract these Merchants to these Accommodations was to have the Balconies of the Building that overlooked the Appian Way staffed by large numbers of female Romans who called down to those Merchants about all of these attractions of these Accommodations. This did attract great numbers of those Gold Coin Merchants to stay at those Accommodations. The Income in Gold Coins from that Huge Building is the beginning and the principal source of sustenance of the City of Rome during those centuries of its growth there. The Economy of the City of Rome operated upon the Gold Coins paid there at that Huge Building. The income from it established the nature of the activities of that City of Rome, thereafter, as it grew to expand into the Roman Empire. If people want to know what it was that was the principal activity there at that Huge Building, that was the main source of the Gold Coin Money that was paid there, that let the City of Rome expand to become the Roman Empire, the answer is in the word that began to be used, at that time, throughout Western Europe, for that main activity for Gold Coins at that Huge Building. It was the word that came from the Romans’ name for that Huge Building, “the Fornix.” That word, used throughout Western Europe, thereafter, for that main Activity at that Huge Building, “the Fornix,” is the Western European word, “Fornication.”

That Huge Building, “the Fornix,” was what could have been the Largest, longest-operating House of Prostitution in History.

In places where prostitution is legalized, like in the State of Nevada, there is often news of vicious punishments of prostitutes. As those news stories are read it seems that

some of the men who hired them did what they did in what may have been a state of intoxication. Then, when they recovered from that and thought of the way that their lives had been so defiled, they sought vengeance upon the Prostitute which they had hired. There seem to be many stories of how the bodies of prostitutes, in Nevada, etc., have been found, beaten to death, some of them so viciously so, with their wounds showing that they were apparently bitten to death, presumably by those who had hired each of those Prostitutes whose bodies were found.

Apparently there was a lot of reactions like that by West Europeans to the way that the lives of their Sons had been so defiled at the Fornix or the many other places like it between Rome and the southeast Coast of Italy. It seems that the beginnings of the Military Activities of the City of Rome began in efforts to repel such attacks, perhaps undertaken to rid Western Europe of this most defiling influence. One such attack is very central to the story of “The History of Money.”

There was a certain group of Celtic Warriors, apparently from the area now called, France, who were trying to destroy Rome. They were trying to perform a sneak attack on a fortress on the Capitoline Hill. This Fortress was near a structure that contained an Idol of the main Female Heathen Diety of the Romans, the Idol of their Goddess, Juno – which name they used to name the Month of June. As these Celtic Warriors were trying to sneak up on this Fortress they had to go through a yard of that structure that housed that Idol. As they did that they disturbed a flock of geese that were feeding in that yard. The Geese began to make noises that alerted the Roman Soldiers in the Fortress to the coming attack. They roused themselves to stop that Attack.

It was said that because these Geese were in the Yard of the structure that housed the Idol of the Main Goddess of Rome, that these Geese were “HER” Geese. Therefore, IT WAS HER IDOL THAT “WARNED” THOSE ROMAN SOLDIERS. Thereafter, she was referred to as, “Juno the Warner.” The Roman word for “warn” is seen in the word, “ad-MONIT-ion.” Thereafter that Idol was referred to as, “Juno Moneta.”

In the course of time, Romans began the practice of pounding out Gold Coins at the feet of that Idol, apparently so that it could be said that she had an influence on them. To this day, in the Spanish Language, “a coin” is, “una Moneda.” “The Mint,” where coins are pounded out is called, “La Moneda.” The word, “moneta,” in the Romans’ Language, changed to “money” in Medieval French, to “Money,” in English. The English word, “monetary,” meaning, “having to do with Money,” originated from, “Moneta.” The English word, “mint,” also comes, through French, from, “Moneta.”

Among the Western European Merchants who brought Gold Coins to Western Europe from Southeast Italy the information became established among them that, “Female Romans will do anything for their Goddess, Moneta, or ‘Money.’ Any time that one is in Rome one can buy ‘Romance’ from them. They are very ‘Romantic.’”

The subject has now been brought up of the Military Struggles of those who lived in Rome with the Western Europeans, who lived on the north side of the Alps Mountains.

It was these Military Struggles that led the Roman people to form their Empire. And, it was these “Nordic” Peoples, who lived on the “north” side of the Alps that, eventually, defeated the Romans’ Empire and/or otherwise replaced it as the many Empires, Kingdoms etc. that were the “Iron mixed with Miry Clay” that were the feet of the Great Image, of Babylon, which are the Kingdoms that are actually hit, by “the Stone” “cut out of the Mountain without hands, Daniel 2:45,” that finally destroys and replaces the Kingdoms of Babylon with the Kingdom of God.

Up until the replacement of the Romans’ Empire, those involved in the Great Image were of the “ethnicity” that is thought of as, “Mediterranean.” These Nordic peoples, whose “Kingdoms” are the final components of the Great Image, of Babylon, are not of Mediterranean Ethnicity; they are of Nordic Ethnicity. So, now that the subject of Ethnicity had been introduced it may be well to examine it.

Ethnicity

Among all of the different Ethnicities or Races of the World, all of the people in them have “Black Hair and Brown Eyes” except Nordics.

“How can Nordics be ‘described’ ‘ethnically’?”

It might be held that the distinguishing ‘feature’ of Nordic Peoples is the presence of “Red Hair.” It is observable that, often, in a family where one of the parents has Red Hair, the children of that family may have any of the “features” of the Nordic Race. For example, some of the children may be blue-eyed blondes, with kind of “blondish” colored Skin. Others may have the “Snow White features,” of very Black Hair and very White Skin. Other children in that family may have any other of the Nordic features.

In the Hebrew Language, the name, “Adam,” means, “Red.” Apparently Adam with his Patriarchal Successor Son, Seth, “the Two Handsomest Men Who Ever Lived,” were Redheads. It is said that the Patriarchal Line that followed them retained the features of their Ethnicity.

There are three Large Divisions of the Nordic Race: the Celts, who lived in West Europe, the Germanics, who lived to the east of them, and the Slavics, who lived in Eastern Europe. They retained the Ethnicity Features of the Patriarchal Line.

The Germanics have always been organized, from the time when they first arrived in Northernmost Europe, around 600 BC, just like Moses organized the Tribes of Israel for Judgment. Germany has always been made up of a number of “Tribes,” each with its own “Land,” just as the Ancient Tribes of Israel were organized. In Israel the “Lands” of their “Tribes” were divided into “Thousands,” the Thousands into “Hundreds,” and the Hundreds into “Tens.” The “Lands” of the “Tribes” of Germany are divided into “Shires,” which are divided into “Hundredships.” In Southern England, settled by part of the Saxon Tribe, from North Germany, Hundredships there are called, “Hundreds.”

These Hundreds, as those of all of the rest of England, are then subdivided down into “Tenships,” pronounced, “Townships,” in Modern English.

[Of course, this is also the “Ancestral Division” of almost all of the USA, divided as it is into its “Townships,” which are organized as “Hundreds,” “Counties,” which are organized as “Thousands,” “Shires,” or “States,” which are organized as the “Land” of the USA. This is also the “Ancestral Division” of almost all of Northern Europe.]

Another indication that the Germanic Tribes were Israelites is the fact of all of their operations functioning on the basis of a Seven Day Week, the Sabbath of which they observed to “keep Holy.”

Days, Months and Years are “natural” things, related to the Sun, the Moon, and the Seasons. The Romans had a system which they followed in relation to them (although they didn’t realize that the Moon produces twelve “Moon-ths” until their Empire’s Infantry Army was defeated by a Germanic Cavalry Army). However, they knew nothing of seven-day Weeks until their Empire’s System began to be replaced by the Culture of the Germanic Peoples.

Persons trying to propagandize “the Government Culture” of the Romans have seemed to have felt that it helps them if they represent to current Nordics that the Ancient Romans looked like Nordics. There are many Nordic peoples living in modern-day Italy. However, they are Germanics who fled there from one of the Dirtiest Tricks played in History. The Government of the Romans told the basic organization of the Nordics that the Roman Empire had accepted their Culture. As a result, the Nordics “let their Guard down,” so to speak. As they did the Romans brought in Hordes of murdering Savages, who had been expelled from China, to overrun the White Race of Northern Europe, kill them off, or enslave them. These exiles from China were, “the Huns.” Their hold became so strong in Northern Europe that Huns then controlled the South Shore of the Baltic Sea for many Centuries, down to the Successful Conclusion of the First Crusade. When the Roman Emperor, in Constantinople, paid Attila the Hun “cartloads of Gold Coins” to go into Westernmost Europe to kill off the Anglo-Saxons etc., Attila’s Principal General was the father of the Last Person to serve as a Roman Emperor in the City of Rome. Many Germanic Peoples fled south, over the Alps etc., to escape from the murderings of the Huns. These are the people who brought Nordic body features to Italy.

“What did Romans look like before that?” In “back-country” etc. places throughout Italy are observable large populations who have perpetuated the presence there of the rather general ethnicity features of the previous Mediterranean Ethnicity. These people are quite a bit shorter than other modern Italians. They seem to uniformly have quite curly, black hair. Their eye color is uniformly brown, and they have the skin color that seems to be common for Mediterranean Ethnicity.

If people wish to know how tall an average Ancient Roman Man was, there is some evidence in the Roman word, “mile.” The original Roman expression, from which the word, “mile” originated, was, “mille passus.” That expression means: “a thousand

paces.” A “pace” is “a step that a marching Infantryman takes, first with one foot, then with the other.” Such Two Steps, by a marching person, are, generally, equivalent to that person’s height. Therefore, “a thousand paces” taken by marching Roman Infantrymen would equal one mile or 5,280 feet. A mile, then, would be the equivalent of 1,000 Roman Infantrymen, laid out head to foot, for one mile. That would mean that the average height of a Roman Infantryman would have been a little over 5 feet 3 inches. That is something on the order of the height of men, whom people see, throughout “back country” Italy, who seem to have the features of the original Mediterranean Ethnicity of the Italian Peninsula.

In speaking of the terror that there was among some Roman Infantrymen in fighting with the Men of one of the Germanic Tribes that had fled south, these Romans were talking about that Tribe’s “7-foot” soldiers. The “average height” of men with Germanic Ethnicity is a little under “6-feet” tall. However, to a 5 foot 3 inch person, someone who is about 6-feet tall is the same as about 7 of that 5 foot 3 inch person’s feet.

So, the ethnicity of the people who created the Romans’ Empire is probably the same as that of the rather general ethnicity that one sees throughout the “back country” of Italy, where the men of those populations are uniformly quite short, with curly black hair, brown eyes and skin that is typical of the Ethnicity found on most of the Shores of the Mediterranean Sea. The propaganda that the Leaders of the Government of Rome were Nordics is only propaganda, as is the propaganda that they were so very ethical, as encountered in a “medieval” Drama of Shakespeare, for example.

At the top of the Forum, at the foot of the Capitoline Hill, the Romans dug a hole into which they threw people who did not pay the Toll that was expected of them etc. That hole was called, “the Carcel.” It is where the English expression, “to encarcerate,” meaning, “to put in jail,” comes from. This is filthy behavior as was the way that they murdered people that they did not agree with. They would take people, men, women and children, strip them naked, nail their naked bodies to a post, and, then, raise it up into the air where their people could finish killing those people by throwing rocks at them, shooting weapons at them, having their Soldiers hack them to death with swords, shove spears into them etc. On one day the Romans nailed 6,000 such men, women, and children to such Murder Posts, along the Appian Way. (As James E. Talmage tells, in “Jesus the Christ,” the Romans did not, because of their “modesty,” wrap a towel around the private organs of their “crucifixion” victims. They were hung and killed by their murderers in the most shameful way that one would expect those among the most shameful murderers in History to commit their murders.)

Those individuals, who established the “Gubernum” of Ancient Rome, through which they controlled the Gold Coin Money Trade into Western Europe, establishing their principal Control over this Gold Coin Money Trade by the operation of their Huge House of Prostitution, and its smaller operations along the Appian Way to Southeast Italy, are, by almost all Standards, some of the Filthiest People who ever breathed the air of Earth. It is very easy to see how John the Revelator, in his final book of the New Testament, would speak of “the Government” then controlling that part of the World as,

“The Mother of Harlots and abominations of the Earth, Revelation, 17:5.” The Romans’ Goddess, Moneta, or “Money,” could, indeed, be thought of as “the Mother of Harlots of the World,” of the Females who sell their Moral Decency for “Money.”

However, when it comes to identifying “the Enemy” of today, in the way that that Enemy operates through the “Kybernion,” “Gubernum,” “Governments” of today, we will need to trace the way that the Gubernum of Ancient Rome set up its Successor, the Government of the Medieval Frankish Empire, which gave to the World the French word, “Government” and was the first of the Medieval Successors of the Roman Empire that became the Iron mixed with Miry Clay Feet of the Great Image, the Governments which “God in Heaven” is going to destroy forever “in the latter days, Daniel 2:28.”

The Feet of Iron Mixed with Miry Clay Governments

“What is it in the Modern Governments of the World, which they inherited from the Ancient Greeks’ Kybernion and the Gubernum of the Ancient Romans, that is ‘the Enemy of All Righteousness’ today, which will be destroyed, by what everyone in the World will think of as Heavenly Intervention, and which will then disappear forever?”

It is that part of those Governments that was inherited from Medieval Feudalistic Governments.

“And, exactly, what is that?”

In order to understand that clearly, we must first understand clearly exactly what Feudalism was and where it came from.

Perhaps the easiest way to begin to address that is to clearly understand how one of the principal things that Feudalism was based on got into Western Europe. Medieval Feudalism began in Europe after the introduction there of large, one-ton, War Horses. These Large War Horses are what made early Medieval Knighthood possible. And it was the corruptions of that early Knighthood that developed into Feudalism.

So, perhaps the easiest way for us to begin is to understand how early Knighthood came into Western Europe. A way to introduce that is to understand why the Romans began their “Empire.”

The Celtic Peoples of Western Europe had quite of few quarrels with the Romans that became Military Conflicts. However, the Romans didn’t feel that they needed to form themselves into an “Empire” until their Conflicts began with the Germanic Peoples, whose “Organizations” came to replace the Romans’ Empire.

Apparently the first home in Europe of the Germanic Tribes was on the huge Island to the north of Europe, which they called, “Scandza.” Today it is the Scandinavian Peninsula. At “the North Cape” of the Scandinavian Peninsula the land rises up from the

Ocean at a rate of about 2 inches a year. In ancient times the Land that is now called, "Finland," was under water; and Scandinavia was an island.

By the First Century BC the Germanic Tribes had grown to populate Scandinavia, so they began going south, down the Danish Peninsula, to populate what became, Germany. When some of them migrated up the Elbe River to its source, in what was called, "Bohemia," the Celtic People who had lived there before, whom the Romans called, "the Boi," fled over the Rhine River into Celtic Gaul, which today is France.

This movement southward of this Race of large-bodied, relative Giants, terrified the People of Rome. So, one of them got an idea. He would conquer Egypt, confiscate the many ancient relicts and artifacts of Gold, that its people treasured and had carefully preserved, melt those priceless ancient artifacts down, to just make Gold Bullion out of them, and then pound small planchets of that Gold Bullion into Gold Coin Money, with his Picture on those Coins. He would then pay out that Gold Coin Money to Romans who would join his Army and do what started the Romans' "Empire."

His idea was to make the Rhine River the Romans' barricade against the expansion of the Germanic Tribes, with all of their large-bodied Soldiers, into Europe to the west and south of the Rhine River, which would, from then on, become the Romans' Empire. He did that by making large Naval Bases at the places that have, thereafter, been the Large Cities on the West Bank of the Rhine River. These Naval Bases were each staffed with many large Vessels built for Warfare on that River. The idea was that if groups of Germanic People got the idea to build some small boats, with which they could cross the Rhine River, over to its West Bank, these Large River Vessels, staffed with many small Roman Soldiers would attack those small boats and shoot arrows into all of the passengers on those small boats. That worked, for centuries; and that was the beginning of the Romans' Empire.

The person who had that idea, Julius Caesar, was murdered by some of his competitors. However, his nephew, Augustus Caesar, eventually replaced him. This Nephew had a bigger idea than his Uncle. He built Naval Bases along the entire South Bank of the Danube River. Then he had the Naval Bases on the West Bank of the Rhine River quickly transport large numbers of Roman Soldiers over the Rhine River to try to conquer the Land between the Rhine and the Elbe Rivers and then build similar Naval Bases on the West Bank of the Elbe River. He felt that by doing this he would force these numbers of large-bodied Germanic peoples, who had filled up Scandinavia and were migrating south, to continue their migrations to their southeast – being blocked from continuing west, by the Elbe, and from continuing south, by the Danube – in this way keeping them away from Italy, rather than letting them continue their migrations to their southwest, which brought them into contact with Italy. It was for this reason that this Nephew was forcing all of the people under Roman Control in the Eastern Mediterranean Area to pay him their Gold, as that is mentioned in the New Testament story of Joseph and Mary needing to pay such "taxes," at the time of the Lord's Birth. However, there were already too many Germanic peoples residing between the Rhine and the Elbe for that Plan to work. In about 6 AD those Residents, under their leader, Hermann, defeated

the Roman Soldiers that were between the Rhine and the Elbe, at the Battle of the Teutoburger Wald, and forced them to flee back to the west side of the Rhine River. This Defeat, of course, had a most dominating effect on the attitudes of the Leaders of the “Gubernum” of the Romans’ Empire, which negative attitudes continued to dominate their thinking as Germanic Peoples gradually took control over virtually all of Europe.

As one would expect, in those Centuries BC, the Populations that had developed the Settlements of South Italy, that became the Cities of Rome, Naples, etc., did what they did to promote their Control over and their Development of their Traffic in Gold Coin Money, between its Origin, in Asia Minor and Greece, and the populations of Western Europe, which populations, through that Specific Traffic through South Italy, came to Sociologically Operate on those South Italian Populations’ Concept of Gold Coin Money. That Busy Traffic, of course, paid for all of the “Gaudy Palaces” etc. that were built, at that time, in Rome and South Italy, which advertised the Opulence etc. which their Control over their Traffic in Gold Coin Money produced. This advertised Opulence, of course, was expected to attract great numbers of Curiosity Seekers to also travel to Rome to see the results of Rome’s establishment of Gold Coin Money as the basis of the Way of Life of those Populations of Western Europe. These “Tourists,” thus attracted to these “Tourist Attractions,” of course, were expected to greatly multiply those “Revenues” that had come from the Originators of those Revenues: first Merchants, then the Gold Coin Merchants, who traveled through South Italy to get the best price in Gold Coin Money etc. for the Goods and Products of those Populations of Western Europe.

However, as the reality began to increase, that the Israelite-organized Germanic Tribes were going to expand more and more throughout Western Europe, from their original Homeland in Europe, their great Island of Scandza (now the Scandinavian Peninsula), it was seen that all of those Opulent Tourist Attractions for the previous West Europeans would degenerate to being nothing more than the “Abandoned Relics” which they became as these Israelite-organized Germanic Tribes expanded across Western Europe and brought their Way of Life there with them.

[The Ancient and Medieval Kybernion/Gubernum/Governments that established the Culture of Gold Coin “Money” as the Culture of West Europeans, till this day, did that by the “propaganda” that virtually everything good in life came from the glorious “Correct Hunches” of those Kybernion/Gubernum/Governments’ “Wise Men.” This Propaganda tells how the “barbarians,” like the “Visi Goths,” the information about whom we will be reviewing next, were the most disgusting of Barbarians, compared with the glorious Romans whom they conquered. However, as we will soon be seeing, the primitive nonsense of the Romans’ “Money” System has been obsolete for some time now, in the modern Information Age. By contrast, the Central Banks of the current World have operated, in these recent Centuries, by the dynamic, world-leading “Customs” of the London Bond Market. By Article 13 of the Magna Carta, those Ancestral “Ancient Liberties and Free Customs” of the Visi Goths who established what the World knows as London, are the exact same today as they were on the day, in 450 AD, when they conquered Roman Britain, established England and began London.

“And, what are some of these ‘Customs’?”

In the Anglo-Saxon Language of the Visi Goths, as it still is in modern Dutch, a “Zitt” is a “Custom.” Many “Customs” are “Zatter.” The Israelite seventh-day “Sabbath” was “Zatterdag,” at the time when the Visi Goths conquered England, as it was throughout all of Germanic Europe anciently, and as it still is in the Netherlands till this day. In Dutch the Roman name for the planet, “Saturn,” is spelled, “Saturnus.” And, although Medieval Romist Propaganda got Medieval English peasantry to believe that their Ancestral seventh-day Sabbath’s name was taught to them by the Romans (who had never had anything at all to do with Israelite “Weeks” until they were conquered by the Visi Goths), from the Romans’ name for the planet, Saturn, all of that is seen as nothing more than the nonsense that it has always been by just learning of the way that all Dutch-speaking People have always called their Ancestral Israelite Week’s Holy Sabbath Day, “Zatterday,” “Customs day,” or “Laws day,” when they had always reflected upon “the Customs,” “the Laws” given anciently to their Israelite Forefathers from God.]

So, as anyone who cares to know these facts may know them, from all of the voluminous Records of the Tribes of the Germanic Peoples that are used, for example, as the basis of modern Genealogy Research, every one of those Ancient Germanic Tribes operated upon the Israelite-Germanic concept of the 7-day Week, a concept that was completely foreign to the populations of the Romans’ Empire before its Conquest by certain of those Germanic Tribes.

And, as just mentioned, on their Seventh-day Sabbath all of the populations of all of these Germanic Tribes heard recitals of their Ancestral Laws or “Customs.”

People can see how that Ancestral Law made the principal Amphitheatre of Rome, its “Coliseum,” into an Abandoned Relic when the Ostro Goths eventually took over Rome on a more permanent basis than the Visi Goths had. In that Amphitheatre the Ancient Romans used to show their Tourists etc. their idea of a good time of witnessing the Mass Murders of Innocent Families and Individuals which the Directors of Rome’s operations considered to be expedient. So, that part of Israelite-Germanic Law that all Germanics had always heard on their Seventh-day Sabbath – in their Ten Commandments – “Thou shalt not kill,” had an effect on making such things as the Romans’ Coliseum into an Abandoned Relic as Controls over Western Europe shifted from the Directors of the Romans’ Empire to its Germanic Conquerors.

But, the Death Knell for so many of the rest of Rome’s Opulent Palaces, Tourist Attractions, etc., was the Death of the Control that Rome developed over West Europe’s Gold Coin Money Traffic, at those Palaces where Rome’s Ancient Tourists could buy Ancient Rome’s Romance, as the Military Control over the Lands of West Europe was taken by – what were very frequently Tribes of Military Refugees – Germanic Tribes who, on their Seventh-day Sabbath, rehearsed that essence of their Ancestral Germanic Law, in their Ten Commandments, “Thou shalt not commit adultery.”

This coming termination of this Control over West Europe's Gold Coin Money Traffic was the earnestness that we now see in the efforts of the Leaders of the Romans to build their Roman Empire to stop that expansion of the Germanic Tribes.

That which had the biggest effect on the Romans' Empire, during its history, is the Information that the Germanic Tribes gave of how Life among them was changed, from living the Law of Moses to conducting themselves according to what was called, "the Law of the Gospel," among them, that appears to have happened at about 40 AD.

That Story, originally told by all of the Germanic Tribes but preserved best in the Records of the Icelanders, was named, the "Story of God," "Gott-spiel," in German, "Guth-spjal," in Icelandic, and "Gospel," in Anglo-Saxon. This Story tells how after the Romans had nailed the Lord's body to one of their Murder Posts, He died, and had risen from the dead, after some time He returned to His People living in what had been anciently called, "Sala," (in Scandinavian Languages of the Middle Ages the City of Jerusalem was called, "Jorsala," the last part of that meaning the ancient city of "Salem," as that name is retained in, "Jeru-salem"). He told the Leaders of His Church there that because "the Roman Chiefs are conquering wide," and bringing their ultimately filthy Way of Life with them, that the Leadership of His Church could not continue to function there in "Asialand." Of course, the Romans' notoriously murderous Way of Life was a threat to all of the Leaders of the Lord's Church, and to their Converts, to inflict upon them the same type of Murder which they had inflicted upon the Lord. So, instead of staying in the Romans' Empire, they were going to need to migrate to the north to have their Leadership establish the Law of the Gospel in those Northern Lands.

[The Story of the coming of the Law of the Gospel to Northern Europe is told in detail in the 1,000-page Course. Here, in this "synopsis," for friends etc. of those who take the Course, only brief references are needed to that Story.]

When the Lord established His Law of the Gospel throughout Northern Europe, as it was administered for some time after that by His Twelve "Temple Priests," that accompanied Him, one of the things which He required as an element of His Law of the Gospel, for the protection of Women and Children, was that all "Young Men," "between the ages of 18 and 45," take the Oath that they will place their Lives between those of Women and Children and the Dangers that might threaten them. This "Young Man 'Ry'" was called, "the Yeo-man-ry," throughout Northern Europe thereafter. Romist propagandists got that word replaced with the Romist word, "Militia," in succeeding Centuries. However, it was the Yeomanry of the Townships of New England that was made into the United States Army that drove the British Army and Navy out of New England, thereafter, forever, to win the US Revolution against Britain. In the wording of the Constitution of Utah, this age specification, of the Ancient North European Yeomanry, is in effect until this time.

When the Leadership of the Roman Gubernum learned that these relative Giants of Northern Europe had been organized into the most effective Military Force in the World, they went Crazy.

The Romans always had a dislike for the people who lived in Judea, at the East Shore of the Mediterranean Sea. These People, who called themselves, “Judes,” were not of the same Mediterranean Ethnicity of the other Populations that lived around the Mediterranean Sea. Instead, their Ethnicity was Nordic; they had Redheads and Blue-eyed Blondes and were of the same large stature as the Hated Germanic Giants, against the expansions of which the Romans felt that they had to take the Military Measures that were the commencement of their Empire.

Then, when they heard that it was Judes from Judea that had gone into Northern Europe and organized the entire Nordic Race into the best organized Army in the World, which could rather easily defeat any Roman Armies, and began doing that shortly thereafter, they unleashed their fury against all of the other Judes still living in Judea or, thereafter, anywhere else in the Romans’ Empire.

They ripped down the Judes’ Temple, in Jerusalem, so that there was not one block remaining on another, and committed other similar devastations throughout the rest of Judea and throughout other Roman Empire controlled areas. These Devastations occurred around the year 70 AD.

When the word of these Devastations reached Scandinavia, very far-reaching initiatives were begun there. As is factually reported in the Icelandic Eddas, the people of all of Southern Scandinavia had elected to change their name and the name of their Land to show honor to the Lord, whom, in their Language, they honored as, “the King of the Jutes.” For this reason they changed the name of all of Southern Sweden to be, thereafter, called, “Juteland,” as it is still called there, till this time. The name for the Largest City on the West Coast of Sweden is still called, in the Swedish Language, “Juteborg,” till this time.

When the “Jutes” of Juteland heard of the persecutions that the Romans were inflicting, upon their fellow Christian Judes, in Judea and elsewhere in the Romans’ Empire, they immediately undertook to provide helps for them. Large numbers of Jutes organized a constant fleet of boats to transport them from southernmost Sweden, across the Baltic Sea to its South Shore. From there they marched overland to the North Shore of the Black Sea. There they built fleets of boats to take them across the Black Sea to locations where many of their fellow Jude Christians lived. In the Book of “The Revelation,” St. John indicates how he is sending copies of the Book to “the Seven Churches which are in Asia.” Those were in Seven well-known Ancient Cities on or near the west coast of what has been historically thought of as, Asia Minor, and today is Turkey. It was perhaps from such Cities as these that the relatively large-bodied Jute rescuers came to rescue the families of their fellow Christians, Judes, and transport them away from dangers from the Romans, over to the North Shore of the Black Sea.

When the Romans heard of this they took their ultimate Defensive Measures. They enacted that all Judes were, thereafter, to be forever banished from the Romans’

Empire. That is the beginning of “the Exile” that, thereafter, is such a central subject in the History of Judaism. This happened in about 130 AD.

However, getting rid of all Jutes, out of their Empire, still left them faced with what they felt was their imminent danger from the large numbers of Jutes who had now migrated from Southern Sweden to the North Shore of the Black Sea. For this the Romans undertook about the Largest Defensive Action ever taken in the History of the Romans’ Empire. There is a high Mountain Range that begins a short distance to the west of the North Shore of the Black Sea, the Carpathian Mountains. At that east end of that Range there is another high Mountain Range, the Transylvanian Alps, which goes to the southwest from there. The plans which the Romans began at this time began a major departure from their previous procedures for organizing their Empire. There is a River that flows through modern Yugoslavia into the Adriatic Sea. Although the people on both sides of that River speak the same Language, those to the east of it write it with the Greek Alphabet and adhere to the Greek Orthodox Religion. Those to the west of that River write that same Language with the Romans’ Alphabet and adhere to the Roman Catholic Religion. It was understood between Greek and Roman Speakers that although the new Roman Empire was expanding to absorb much of what had been the Greeks’ Empire, east of that River (in what is today modern Yugoslavia) the Romans’ Empire would be run in the Greek Language, just as though it was still the Greeks’ Empire. All of that changed though with this Largest Defensive Action being taken, against the Jutes, on the North Shore of the Black Sea. Tens of thousands of Romans from Italy migrated over, to what was eastward from that River, and created the new Land of Romania there, which speaks the modern descendant of the Romans’ Language there till this day.

The Romans built a great number of Large Fortifications along the crest and north side of the Carpathian Mountains to protect themselves against these large-bodied Jutes who had migrated to that area.

As might be expected the Jutes reacted by taking certain defensive measures to protect themselves against all of those Romans who had moved themselves into that area where they formed Romania as a military measure against those Jutes.

As such defensive measures were taken the Jutes came upon two Developments that determined the Military History of Europe for, approximately, the next 1,000 years. One of these Developments has to do with the land area that is on the North Shore of the Black Sea. That Land Area is part of “the Great Plains” of Eurasia, which extend from the Alps Mountains across Eurasia to Manchuria. The Great Plains of Eurasia are known as, “the Steppes.” Many types of grazing animals occupy the Steppes. So many varieties of Horses were found there that the Steppes became known as, “the Homeland of the Horse.” One type of Horse that the Jutes encountered, as they made the Steppes their new Homeland, was the huge, one-ton type of Horses, that Europeans and Americans thought of as the large “Work Horses” or “Draft Horses” that were so important in Modern Agriculture before they were replaced by Machinery.

Apparently many of the large, 6-foot+, 200-pound+ Jute Men began using these Large One-ton Horses, that they found on the Steppes, for their transportation. To facilitate riding them they invented something that, in their Jutish Language, they called, a “Step-rope.” A “Step-rope,” in the Swedish Language of the Jutes might have been something like, “Stig-rup.” That became, from Jutish, to be the English word, “Stirrup.”

So, these Jutes were the Inventors of the “Stirrured Saddle.” It was the conventional Modern Saddle, with two Stirrups, into which a rider places that rider’s feet, plus a strap around the chest of the Large Horse to provide a stability to the Saddle. It may be seen, by looking at statues of Roman Emperors mounted on horses, that, except for a small cushion, Romans rode horses, almost, “bareback,” when they rode them.

On the other hand, the Stirrured Saddle, invented by the Jutes on the North Shore of the Black Sea, is considered by all Experts on Military History to be “The Second Most Important Invention (after Guns) in Military History.” With their Stirrured Saddles, these large-bodied Jutish Men found that THEY COULD DELIVER THE ENTIRE VIOLENCE OF A ONE-TON CHARGING WARHORSE INTO THE TIPS OF THEIR LANCES, if they were mounted on their Large Horses, on Stirrured Saddles.

These two Developments, by those Jutes, at that time, of “domesticating” the Large “War Horses” and inventing the “Stirrured Saddles” to use with them, possibly a little after 200 AD, created Knighthood and became the main element in the Military History of Europe, and surrounding Areas, for the subsequent, approximately, 1,000 years. Before these two Developments, “lancers” had been restricted to only the power of their arm, to deliver the blow from their Lances. With these two Developments, though, and with these Jutish men placing Armor over themselves, to protect them from arrows, etc., the era of Knighthood began.

As these Jutish Knights reacted, to protect themselves and theirs, from the aggressions against them from all of the thousands of Romans, from the Fortifications that the Romans had built along the Carpathian Mountain Range, against the Jutes, the Jutes found that, with their new Invention of Knighthood, they could not only withstand anything that the Romans tried against them but that, by merely withstanding them with their Knighthood, the terrified Romans abandoned Romania and fled back toward Italy.

Many of these Jutes, therefore, with their Knighthood, decided to locate themselves in what they found was, in a number of ways, an abandoned Romania. This was about 270 AD. When they did that the Romans then began stooping to their lowest Insanities. The reason that they did was that, without Romania, the Romans had no more of their Empire’s “protection” for Italy. That is explained as follows:

The Romans’ Rhine River Fortifications did produce a barrier, against the continued westward and southwestward Migrations of Germanic Peoples, for Centuries. However, for one reason, the Danube River, along the South Bank of which Julius Caesar’s Nephew built his Line of River Warfare Installations, in imitation of those which his Uncle had built along the West Bank of the Rhine River, was worthless as such

a barrier. Even though the Danube is a larger River than the Rhine, it is worthless as such a Military Barrier that the Rhine serves as because, as it goes through what is the western end of the Great Plains of Eurasia (as they end in the Country of Hungary), the Danube broadens, becomes shallower and, sometimes, freezes so solidly that a modern Railroad Train could be driven across it. As long as there was some theory of keeping the large Jutes, with their Knighthood, away from that frozen-over River, by the Fortifications in the Carpathian Mountains of Romania etc., there was a theory against the thought of those Jutes with their Knighthood coming into Italy. When those Fortifications were abandoned by the terrified Romans' Soldiers there was no such theory anymore.

“What could the Romans do?” If they actually were among the “Filthiest People who ever breathed the air of Earth” they could stoop to their absolutely lowest Insanity ever. “Did they do that?” Yes. “What was that?”

When the Romans drove all Judees out of their Empire forever the Leaders of the Sect of the Pharisees, of New Testament Infamy, fled to what was still the Ancient City of Babylon. There they “re-grouped.” “What was that?”

They, apparently, said that somehow, the Lord, whose murder they had urged upon the Romans, had survived. He had returned to Jerusalem and taken most of His Followers, who were healthy enough etc. to walk from Judea to Germany, to Northern Europe. There He succeeded in organizing nearly all of the Nordic Race as Members of His Church. Those Pharisees then reasoned that if they, then, were going to be able to survive as an Organization, they were going to need to “regroup.” Some of the details of this Regrouping can be found in the Encyclopedia Judaica, under the heading, “Exilarch.”

There in Babylon City they found a person who was descended from the Family of the Ancient Kings of Judea, which Family had been taken captives into Babylon at the time of its Conquest of the Ancient Kingdom of Judea. The members of that Family were the Descendants of King David, from which Lineage the Messiah was to have descended. They took this Person and told him that they were recognizing him as their “King of the Exile (their Exile from Judea)” and that he would thereafter rule over them as their King of the Exile, their “Exilarch.” That person then accepted that dignity from them. Then they also told him what they needed him for. They told him that from then on they were going to recognize him and his successors as their “Messiah” of Israel. Phariseism has operated, from that day till this, under this Exilarch, whom Pharisees, thereafter, have recognized as their Messiah. From the point of view of that Position, as well as from the point of view of what the holders of that Position have done, this line of people seem to very clearly be those to whom St. John the Revelator refers, in his Writings, as “the Antichrist.”

The Pharisees organized themselves very intensely around their new Exilarch. One of the things which they did was to show, what had been a rather insignificant Chieftain, of the area of Persia, how they could organize his followers so intensely that he could use them to found a new Persian Empire. He did; and it became known as, “the Parthian Empire.” After a while a Roman Emperor became so irritated with this upstart

that he went over to conquer him. However, to everyone's surprise, his followers had been so intensely organized by the new Exilarch and his followers that that upstart beat that Roman Emperor in their Battle and, thereafter, put him in jail for the rest of his life.

After the Romans had recovered from the shock of this unexpected reversal and had time to think over what had happened to them, they approached the Pharisees' Exilarch to tell him that they were interested in his advice. They recounted how the Pharisees' enemy, the Lord, had, apparently, survived what the Romans had thought was their murder of Him, and had taken the Members of His Church up to Northern Europe where He organized such people as the Romans' current enemies, the Jutes, in the way in which they were organized thereafter. The Romans then asked the Exilarch and his Pharisees if they, with their singular insights into the traditions with which their enemies, the Jutes, were then operating, could then suggest some way that the Romans might be able to effect a Military Victory over the Jutes.

This Antichrist and his Pharisees said that they did know how to do that.

They told them that the Romans' part in this would be to go to Leaders among the Jutes and to tell them that, because they observed the wonderful moral way in which all Jutes conducted their Personal Lives, the entire Roman Empire has become converted to their Church and wants to do things according to "the Law of the Gospel," that the Jutes lived by. The Antichrist told the Romans' Leaders that, of course, they did not need to actually do that. A vital point was that they stop teaching anybody, except those preparing for the careers in the clerical services in the Gubernum of the Romans, how to be able to read and write the Romans' Language. This would prevent the Jutes from learning what the Romans were really up to. The Leaders of the Romans' Gubernum were told that they could keep right on with their Conducting of the Gold Coin Money Trade of Europe as they had been. They could keep on operating all of their Large Houses of Prostitution under their "One-Spin-al Man," their "Universal" or "Catholic" Connection to the Brainless, Body-less Fool of a Greek Theos, who makes the Sky spin around the Earth every Day and Night, from whom their "Catholic" Leader gets his "Correct Hunches," "Ortho Doxy," that lets him operate their Gold Coin Money Trade based "Gubernum," in the tradition of the Greeks' "Kybernion," and they could keep calling that Leader their "Baba" or "Papa," of the Babylonian origin of that Trade, just as long as they rigorously kept hid from the Jutes how they can learn to read and write the Romans' Language. The Antichrist then told them that the Jutes will become so confused and disorganized by their inability to understand any of the things which the Romans are doing that they will be open to a very most Crushing Military Defeat.

They were told that the part in this that the Antichrist and his Pharisees would perform is that they, through their very well established connections throughout the Parthian Empire, were in contact with a most wild and ferocious people, known as, "the Huns," who had been exiled because of their wild and ferocious behavior from China and were then living on the Great Plains of Eurasia (in, perhaps, where modern Mongolia is). As soon as the Jutes had become thoroughly confused about how they were supposed to take even the first step to bring in all of these millions of their new Converts into their

Church, who had been so converted because of the exemplary moral behavior etc. of the Jutes, the Antichrist and his hordes of wild and ferocious Huns fell upon these unsuspecting Jutes, from out of the Great Plains of Eurasia, to their east, and, against almost all of them, butchered them, scattered them, or enslaved them, ultimately, nearly all of the way west to the Channel Coast of West Europe.

One thing that the Romans were going to have to do, of course, was to revoke their Edict of Exile against Pharisees and, henceforth let them travel as they needed to throughout the Romans' Empire as the very most significant Leaders of the Romans' Gubernum, that they had become, after that time.

Prior to this, in the chaos for the Romans of the loss of Romania etc., they had taken a step that the "teacher" of the "Most Ignorant Person," mentioned before, said could need to be done when the Workers of a Kybernion seemed to be facing certain defeat if they did not resort to such drastic measures. That Step, proposed by that "teacher," was that a desperate effort for survival of a Kybernion, such as the Kybernion that he and his associates were trying to formulate against the Persians at that time, was that, in such most desperate circumstances, all of the "clerical workers," who kept the machinations of the Kybernion going, may all have to renounce all marriage relationships and family life, so that none of them could have any legitimate offspring nor a spouse, to claim any inheritance from them, but that ALL of the Results of the Labors of those Workers, to keep the machinations of the Kybernion going, would, unquestionably, remain the Property of those still trying to perpetuate the Kybernion. That Teacher mentioned that such Workers, male and female, could have all of the illicit sexual relationships among themselves that they wanted but that they would need to be most secretive about them, in relation to the public, in order to not alert that public to any actions that they might take against the Kybernion.

Such a monastic arrangement among the Clerical Workers of the Romans' Gubernum was being established as the Pharisees' Antichrist explained to them how, from then on, no one could be trained in how to read and write the "Latin" Language of the Romans except such Clerical Workers. This restriction of the teaching of reading and writing skills to none but those training to become the Clerical Workers of the Romans' Gubernum is the action that was taken that made it so, in time, the Latin Language of the Romans became "a Dead Language."

As the Antichrist had told them, the Jutes had become so disorganized as they tried to understand how they were to perform the duties they were obliged to perform, for new Converts to their Church, among all of the millions of those "Citizens" of the Romans' Gubernum, that they became very vulnerable. There was no way available to them to understand the "overall" things that the Romans' Leaders were involved in, so they simply had to hold in a disarray the obligations of the duties that they understood that they were to perform for new Converts coming into their Church.

In this condition of quite a bit of disorganization, from out of the Great Plains of Eurasia, to their east, descended upon them enormous hordes of mounted Hun Warriors who proceeded to quite easily butcher, scatter and enslave great numbers of them.

When this happened, one Group of the Jutes who were provided with a protection against such Surprise Attacks were the Jutes who had taken over Romania. There were about 100,000 of them, men, women and children. They had possession of the Romans' old Fortifications, along the line of the Carpathian Mountains etc., from which, with their Knights, they were able to keep these Hordes of Huns away from them.

[Now to consider the Name of "the Jutes." These are "the Tribe" of the Anglo-Saxons who drove the Romans out of most of Britain and transported the other Anglo-Saxons over to Britain to live there. Most people know that the Three Tribes of the Anglo-Saxons were: the Angles, the Saxons, and the Jutes. These are the "Jutes" (the way that their name is pronounced in English) who are those whose activities are being considered in this written information about them. As they all frequently said, they originated from Southern Sweden. There in Juteland their name, in Swedish, is pronounced in a way that might be represented as: the "Jertter." That pronunciation was not pronouncable by Romans, who devised the name, "Gotti," for them. So, much of the world, seeming to be operating on the Romist propaganda of the Romans' Gubernum, identifies these People, in English (even though these were the Knights who created what became "England," in the first place), as the "Goths," from the Romans' "Gotti." And, although these people are the ones who established so much of what is thought of as, "English Law," in the south of England, the land of their origin in Sweden is called, "Gothland," in English, and the Large City of that part of Sweden, "Gothenburg," even though those pronunciations have next to nothing to do with the way that these people, who originated the people who originated England, have always referred to themselves.]

During that period of time during which these Jutes, of whom we are now speaking, lived in Romania, they divided it into Germanic Tenships (Townships), Hundreds and Shires. Since these people, who invented Knighthood, are the people who became the Founders of the City of London, it is convenient to explain their manner of organizing the way that they lived in relation to the way that London is organized.

London is rather easy to explain to Latter-day Saints, since the way that London has always been operated, since the Jutes first established it, is – in the thinking of some Latter-day Saint General Authorities who lived there for long periods of time – the way that local parts of the LDS Church have always operated.

The Forefathers, of the early Latter-day Saints, who came to New England from London operations in England, organized New England into "Townships." In London a Roman name, "parishes," came into use for them. A number of London Parishes form a London "Ward." Although local LDS congregations get their name, "Ward," originally, from such establishments as the London establishments of that name, London "Wards" are identical with LDS "Stakes." Each London Ward is presided over by an Alderman and his Twelve "Wardens" who are, respectively, the Judge and the Jury of the Grown

Men of the Ward that determine the judgments for how each of those Grown Men have kept their Oaths, to obey the Law of the Gospel, that they made in London's Temple, that gave them their "Gospel Rights" of London "Free Men." Most Latter-day Saints easily see the relationship of the Alderman and his Twelve Wardens, of a London Ward, to the Stake President and his High Council, of an LDS Stake. London was established, to operate that way, when the Jutes first drove the Romans out of that area and founded London in about 450 AD.

All of Northern Europe used to be organized in this manner: Tenships, organized into Wards, under a Judge and Jury, who judged the Manhood of the Ward as to the faithfulness by which those men kept their Temple Oaths, to obey the Law of the Gospel, that they made in their local Temple. All of the Wards of Northern Europe are still organized into "Temple Districts." The Roman Catholic Church had the Feudalistic Leaders of its "Gubernum" become "Governments," destroy all of the previous Temples of the Germanic People of Northern Europe, except one, one that was off-limits to them. That was the One in London that was kept off-limits to them by the Sea Farers of England who operated out of London.

Throughout Northern Europe each Temple was presided over by a person who was called by the ancient Germanic Name for the Leader of the Temple in Ancient Salem. That person is known in the Bible as Melchizedek. In Northern Europe he was known as "Jarl," pronounced, "Earl" in Britain. These men had nothing, directly, to do with the Feudalistic officials of later Centuries who bore those titles. These men were each the President of the Temple of his Temple District. A Temple District, on Britain, was a Shire (in some places made up of many "Wards," till this day). London was considered to be a "Shire," which had its own "Shire-reeve," the "Sheriff of London."

Throughout Northern Europe the "Free Hold" of the Earl of a Shire, on which was constructed the Temple of that Shire, was known as a "Vi" (a "Wi" in England). After a Man had gone through his Temple, and taken his Oaths therein to obey the Law of the Gospel, he was considered to be "vis" in Northern Europe. That is "wise" in English. The Giant Island of Gotland, from which the Crusaders' Hanseatic League operated, in the Baltic Sea, has had, as its traditional place of leadership for so many centuries, the Community of "Visby," the "By" or "Township," on the "vi" of which "By" the original Earls of Gotland, located the Temple of Gotland. Because the Crusaders' Hanseatic League had so much to do with the establishment of Modern Worldwide Commerce, any expert on Maritime Law will tell us that, "The Laws of the Ships that Conduct Trade on the Seas of the World Today Are 'The Sea Laws Of Wisby.'"

In Romania, the Jutes built so many of their Christian Temples throughout all of the Land that the "Vi-s" on which they built them seemed so numerous to those who were interested in what they were doing there that those people devised the name for this segment of the Jutes that has been used for them since: "the Visi Goths." These Jutes were protected somewhat from the Ravages that the Huns were executing on their fellow Jutes, who had remained on the North Shore of the Black Sea. However, it seemed wisdom to the Leaders of these Jutes to leave the new Homeland that they had built up

for themselves in Romania and to put some distance between themselves and the Ravages of those Hordes of Huns that outnumbered them by so many. Those Leaders got the idea that they would ask the Leaders of the Roman Empire's Gubernum, who lived in Constantinople, if those Leaders would give them permission, to cross the Danube River, from Romania into Roman Empire Territory, and exit from that part of the World to go to the West. Even though they had many insuperable problems in trying to communicate with these People, who had told them that they had converted to their Religion because of their exemplary Moral Behavior, they did that, and were informed by the Roman Emperor who ruled from Constantinople that they were invited to try to take their Families to a greater security by passing through that part of the Romans' Territory.

Accordingly these Jutes got their possessions together and transported those possessions and their Families over the Danube River and, then, down to the vicinity of the City then called, Adrianople, but today known as Edirne, Turkey, which is about 130 miles "west by" northwest from that Capital City of the Romans, Constantinople.

Soon after getting there these Jutes learned that, far from Romans now wanting to be their Fellow Christians, who wanted to try to adopt the High Standards of Moral Behavior of the Jutes, living their Law of the Gospel, the Romans remained, as a people, among the Filthiest Murderers who have ever breathed the air of the Earth.

These Jutes numbered about 100,000 people. It is calculated that that meant that there were about 20,000 men, of fighting age, about 20,000 women, 40,000 children and, perhaps, about 20,000 older persons. Of their 20,000 men, of fighting age, it would be doubtful if more than about 8,000 of them were Armored Knights, mounted with their Lances and other weapons, on their Stirrups Saddles on 8,000 One-ton War Horses. There, in the distance, they saw, coming from Constantinople to murder them, about 150,000 Roman Fighting Infantrymen, led by the Roman Emperor of Constantinople.

There, in the vicinity of Adrianople, on August 9, 378 AD, these Fathers of these Families had to leave them, trusting God to save them, and charge, as 8,000 Knights – of course supported somewhat by the 12,000 or so other Jutish Men, their Sons etc., with more minor weapons – into the advancing Army of some 150,000 Roman Infantrymen, coming to kill them off and to then wreak unspeakable horrors upon their helpless Wives and Children.

Although the Romans were, comparatively, smaller than the Jutes, it is expected that they had their Largest Soldiers marching in the front, as their Shield Bearers, to minimize, as much as possible, the Damages that the Weapons from the Opposing Force could do to the soldiers of their Army that were advancing behind them.

However, when the Lances of the first Jutish Knights touched the Shields of the first Roman Shield Bearers, the Military History of the World changed from that Moment on. When the Lances of those Knights, on their Stirrups Saddles on their Mighty One-ton Charging War Horses, delivered the entire violence of those Thousands of One-ton Charging War Horses into the Tips of those Lances, it seemed that even the largest of the

Romans' Shield Bearers were knocked up into the Air "like so many volleyballs." Those War Horses and those Knights then proceeded to Trample to Death or otherwise end the lives of about 40,000 of those 150,000 Roman Infantrymen from Constantinople, including the Life of the Romans' Emperor, Valens, who likewise died in that First Onslaught. All of the Romans' other Infantrymen, who were not killed by that First Onslaught, fled, screaming for their Lives, back, hoping to get to the Walls of Constantinople before a Jutish Knight got them first.

All Military History changed with that First Onslaught. With the remainder of those Roman Soldiers fleeing for their Lives, back behind the protection of the Walls of Constantinople, Romans, basically, gave up their control of all of Europe West of the Walls of Constantinople. Any of Europe to the West of those Walls, was the Property, now, of those Jutes, that is, any of it that they wanted.

That First Onslaught, by Armored Knights with Lances on One-ton Charging War Horses, was the End of the Romans' Empire, as they had operated it for Centuries. They would still have what they called, a "Roman Empire," but it was basically a Greek-speaking Navy, operating out of the Naval Base of Constantinople. Roman Armies were, basically, from that First Onslaught on, a thing of the past.

As was said, it is held that, "The Invention of the Stirrured Saddle is considered to be The Second Most Important Invention in Military History, after Guns." And, just as the previous Roman Empire can be said to have ended with that First Onslaught, "the History of Knighthood," that dominated the succeeding 1,000 years of European Military History, began with that First Onslaught.

If all of Europe to the west of the Walls of Constantinople was theirs, if they wanted it, "What did they want?" It appears that it didn't seem to them that there was anything in that part of the world that they wanted very much. The hilly country on that southern part of Europe, that contains Greece, probably was nothing like the extensive Pasture Lands that they needed to keep their thousands of big hungry Horses healthy. So, after staying there for a while, they headed west.

When they eventually came into the large Valley of Northern Italy they ran into a Problem. The Leader of their Cavalry was a man named, Alaric, who held the Office of what the People of London would say was, "the Alderman of one of our Guilds." LDS People might say that his Office was like that of a President of a Stake, the President of the High Priests Quorum of that Stake. However people who honor that type of an Office might try to describe it, the Jutes found that they could not stay in Italy because it seemed like so many of the people there had a focus on their murdering that Leader. So they had to quickly continue their journeys. However, they had problems as they tried to do that. That unconscionable, surprise, fight-to-the-death Attack upon them by the Roman Emperor from Constantinople, obviously did a great deal of damage to them, even though they won the Battle. "How much of their Supplies, Livestock, Food and Clothing Production Equipment etc. was destroyed or lost then?" They had stayed in one place or another until they got to the Valley of North Italy, but now they needed to quickly leave.

They needed to quickly organize and supply themselves for a, perhaps, very difficult move westward over the Alps. This Leader thought that he would try one more time to appeal to a Roman Leader, of the people who had said that they had joined Christianity because of the Jutes excellent example, to ask that Leader, of the City of Rome, if it would be possible for the people of Rome to spare some of their Supplies to their Fellow Christians to help them on their way. The response from that Roman Leader was what the Jutes' Leader might have anticipated. The Romans' Leader said that, although the Romans didn't have an Army anymore, if the Jutes tried to come into the City of Rome to seek for supplies, the People of Rome would be told to pick up their Sickles and their Scythes and come running at the Jutes to kill them. In the German Language History that tells this Story, the Leader of the Jutes, then, in his disgust, said, "Dass das Gras sich so leicht mahen lasse!" "Oh, that it might be so easy to mow the grass down!"

The Jutes had no alternative; they had to get some Supplies to continue on. Now the Jutes' Leader knew that all of the Romans had been lying to them as they said that they wanted to join the Christian Religion. So, in his Message to the People of Rome, telling them what they could expect as his Jutish Knights came into the City of Rome to seek for survival Supplies, he as much as said, "I now know that you are not sincere Christians, like you have represented yourselves to be to my People. However, in the event that there is such a thing as a Christian Church house in your City, to the extent that any of you want to take refuge in it, I personally guarantee you that none of you will be hurt in it, in any way, by any of the Men under my Command."

[With this, it is now time to talk somewhat about, "Civilization." It has been estimated that in both the Greek and the Roman Empires about half of the Population involved in each were Bond Slaves. Slaves do not have a High Standard of Living. And, although Prostitutes may have access to some pamperings, nobody in the World will think that the vast numbers of Prostitutes of the Romans' Operations ever had a High Standard of Living. On the other hand, wherever the Germanic Tribes of Northern Europe have ever lived or ever settled, the evidence is that they have consistently always had the Highest Standard of Living of any People in the World. They have it now and have had it back through all of the History of them that is known. Virtually all of the Men held the Office of "Free Men," just as the predecessors of the 500,000 current London Free Men did. Those 500,000 London Free Men control the Finances of the Entire World, as they have through recent Centuries. They have, uniformly, the Highest Standard of Living in the World, among themselves; and they have had that for recent Centuries. Among the Manhood of the Germanic Tribes of Europe, where virtually all of their Manhood held the Office of "Free Men," Slavery has been UNKNOWN. Romist Propaganda seems to love to show "The Conquest of Rome, by the Barbarians," as thieving Bands of shabby-looking White-skinned Men plundering Roman Treasures before attending to the rape of virtuous olive-complected women who had fallen into their control. The actual fact is that the Leader of the Jutes, who seems that he was more virtuous than anyone whom he met in Italy, certainly more so than any of the large numbers consistently intent on his murder, made it very clear, and it is an historical record that anyone can access, that if any Romans would just go into a Christian Church, if there was such a thing in those days in Rome, he personally guaranteed that none of his

Soldiers, seeking for Survival Supplies, would hurt them. When they obtained those sufficient Survival Supplies the Jutes then moved on and, soon thereafter, left Italy, probably better off, for their having been there, contrasted to the Terror preached, since the days of Julius Caesar, of what they would do to Italy if they ever came there.]

“Where could they go from there?” They went over to what is today Western France. After they got there one of the biggest Military Attacks in History was plotted against them, by the Emperor at Constantinople, probably with the help of the Antichrist.

There was a Leader of the Huns who had settled in Hungary who had risen to a unique prominence among the Huns. One of the ways that he accomplished that was by murdering all of his relatives who might have been able to make a claim upon the rulership that he exercised. Because of such Tactics he was the Ruler over huge numbers of the Huns who had swept into Eastern and Central Europe. The Roman Emperor in Constantinople made a deal with him. It was that he was sending him “Cartloads of Gold Coins” to pay him to take his Hordes of mounted Hunnish Warriors west, into France, to kill off the Visi Goths who had sought refuge there. That Hunnish Leader, Attila the Hun, accepted the offer. Attila’s Main General was a Roman, the father of the last person to serve as an Emperor of the Romans in the City of Rome.

As Attila was planning his attack on the Jutes in France, some of the smaller groups of Huns, under his overall command, were harassing very badly numbers of refugees who had fled from Hunnish attacks in the Danish Peninsula and in Northern Germany. These were the Angles and the Saxons. As the Jutes occupied what had formerly been Roman Gaul, today France, they took into their control a number of Sea Ports on the Coast of that Land. The Angles and the Saxons pled with them to transport them across the Channel, in the Sea Craft under their control, and let them escape from the attacks of the Huns upon them by their taking up residence in Britain. In order to facilitate this the Jutes first shipped large numbers of their Knights, with their War Horses, across the Channel and up the Thames River as far as the Tide would carry them. They named the Place where they unloaded their War Horses, “the Grove,” “Lunden,” in modern Swedish, apparently the origin of the name, “London.” From that point the Jutish Knights merely got on their War Horses and harried all of the Roman Foot Soldiers that they encountered in Britain out of the choicer lands of the east of Britain and over to the Hills in the west of Britain. This place was thereafter named, “the Place for Roman Soldiers,” which is the name, “Wales.” The Jutes then proceeded to transport the Angles and Saxons away from the Continent, where they were in danger from attacks upon them from the Huns and over to the safety afforded to them on the Island that the Romans had named, “Britain,” but to which they gave the name, “England,” for that part of the Island where they made their Settlements.

The Angles, Saxons and the Jutes then organized their new Country of England into 40 Shires. The Angles and Saxons resided in 38 of them, the Jutes in two, with superior Harbor Facilities, Kent Shire and Hampshire. However, the Jutish Knights also organized their London, as their Headquarters, relative to which there is very much more in the 1,000-page Course. These events happened in 450 AD. However, in 451 AD

Attila the Hun made his attack into Western Europe. To thwart it the Jutes had to summon all of the Resources which they had available to them for their Huge Battle with Attila's Forces, that took place near the City of Chalons sur Marne, about 70 miles directly east of Paris.

With all of the Forces that were mustered with Attila, it may be hard to determine how many Roman Soldiers served under the Roman General that was Attila's Main General, they were not a match for the power of the Jutish Knights on their Huge War Horses. Attila was beaten and the main body of his Forces needed to flee, for their Survival to the southeastern-most part of Europe or beyond that into Asia. The Romans were finished as Military Attackers, but the Antichrist wanted one more try.

He created the Mohammedan Religion by having some of his Phariseic Rabbis in Arabia write the Koran for Mohammed, who was illiterate. The Plan was to create the Mohammedan Religion to attack Europe.

After the Jutes had defeated Attila it seems that, by what might be thought of as, even, "Prophetic Insight," they knew that those who were residing in France needed to leave France and, instead, move South and establish Spain. They established it as the Stronghold to withstand an Attack from their Enemies coming across North Africa and then crossing over the Strait of Gibraltar to have access into Europe. The Jutes who formed Spain were there for over Two Centuries before Mohammedanism was formed to create the Army that would cross North Africa and drive the descendants of the Jutes out of most of Spain into Northernmost Spain, from which, over the succeeding Centuries they mustered the Strength to eventually drive the Mohammedans back out of Spain, during the Crusades etc.

However, after the Mohammedans attacked Spain during the 700's AD, and tried from there to make some type of a Plan for advancing into Europe but saw the impossibility of that, because of such things as the huge numbers of Giant War Horses that there now were there etc., the Antichrist and the Emperor in Constantinople knew that they were not going to be able to defeat Nordic Christians, with their adherence to their Ancestral Law of the Gospel and their Development of Knighthood. That is, their Knighthood had spread throughout Western Europe, as the Giant Horses brought over to Western Europe by the Jutes were highly sought for and bred to produce as many of them as the large-bodied men of Northern Europe wanted, to allow them to defend themselves as Knights. And there were other advantages which they had put in place to assure their Continuation of their Way of Life in Northwestern Europe.

These Enemies then knew that they were not going to be able to Conquer the Nordic Race Militarily. Now they knew that that was not going to happen. The only possibility left to them, to inflict a "Defeat" upon the Nordic Race now, would be trying to inflict a Mental Defeat upon them, that would allow them to be Controlled by their Enemies. The following is what they then tried. As you see what they tried, you will see very clearly what your Enemy is, in your Everyday Life.

“Governments”

As we now see how the Enemies of Mankind put together the “Governments,” that are the “Iron mixed with Miry Clay feet” of the Great Image, it becomes very clear exactly what it is that is “the Enemy of Mankind.”

Moreover, it is no mystery at all as to how all of these Governments will be destroyed. Virtually anyone who knows anything about the Bible knows that in the Latter Days “The Wisdom of their (the World’s) wise men will PERISH, Isaiah 29:14.” It will perish because everyone in the World will see that ALL that the “wisdom” was, of those who offered themselves to be the World’s Wise Men, to create their “Governments” for them, was only the Wisdom to TRICK Stupid People. The Last Days are the Information Age, the Age when all Information will be available to Everybody, on the Internet. Everybody in the World will be able to see how that “Wisdom,” that was sufficient in Ancient Times, to TRICK Stupid People into serving Stupid Ideas, are, today NOTHING more than just a Bunch of Stupid Ideas, that NOBODY WANTS ANYMORE, SO THAT THEY WILL BE GONE, FOREVER, “THE WIND CARRIED THEM AWAY, THAT NO PLACE WAS FOUND FOR THEM, Daniel 2:35.”

So, let us now see how the People who had lost their “Gubernum,” over European People, took the steps to try to continue that when, after it was seen that Mohammedanism could not defeat Europe, they decided to set up the Empire of the Franks, under “Charlemagne,” to be the First “Government” to control the Minds of the People of Europe by Tricking them.

1. [Charlemagne’s “Government” was set up in what is today France. Right across the Channel from it, in London, for Centuries before Charlemagne, the People were organized, in the same way that they are today, who control the World of Finance. When they began they called themselves, “the Jertter.” The Romans, who the Jertters’ Knights had conquered, called them, “the Gotti.” They were a Nordic People, who would not be separated from their adherence to “the Law of the Lord’s Gospel,” which they took their Oaths to adhere to, in their Temple, that they built, and that their Commonwealth of London operated according to. They are still there today. Their Temple is still the Focus of all “Law,” wherever it is studied throughout the English-speaking World. Their Language has become the World Language. In their “Commonwealth” of London they have always operated, one with another, on the basis of what, in their Anglo-Saxon Language, they called, “Wealth,” the “Voting Stock” which they got according to how well they adhered to what they promised God that they would do, in His Temple.

Their Voting Stock has completely replaced Gold today, throughout the World, as the “Medium of Exchange” for the entire World. In 1997, 15 Trillion Dollars worth of Voting Stock was bought and sold every day on the Internet. That is about \$2,500 for every man, woman and child on the Earth today, every day. In contrast, there has only been ½ Trillion Dollars in Gold that has ever been mined, in the History of the World. That is about \$80 for every person in the World, one time. There is no way that the Modern World can operate on Gold. They operate on the Jertters’ Wealth.]

2. [It is interesting that, today, probably the most popular Series of Movies in History is the Star Wars Series. In the recent Trilogy of those Movies the Movies' Producer has the Jeddi Knights, operating from their Temple, at the center of the Metropolis that is the Leadership Location for many Worlds, committed to adhere to their Law, in order to continue the best results for everyone. Since "Jertter" + "Gotti" seems to = "Jeddi," later in this Synopsis the Jertter's Knights are called, "the Jertti Knights."]

Now, to very specifically see "What" "the Enemy" is, that controls the "Governments" that continued Babylon's Way of doing things, after the "Kybernion" and the "Gubernum" had failed, we see the following Scenario.

1. They tried to take the Leadership away from the Nordic Race. That failed.
2. They tried to interrupt their adherence to the Law of the Lord's Gospel. That also failed.
3. They wanted to continue their Babylonian Tradition of "Government" based on Gold Coin Money.

The following is what they did:

1. They took the Large War Horses that the Jutes had brought into Western Europe and saw to the production of enough of them for them to commence Knighthood as it was thereafter practiced generally, in an imitation of the way that Knighthood had begun and continued among the Jutes' Knights.
2. They took the Germanic Tribes' Divisions of the Lands of Northern Europe and corrupted them. They had it so that, instead of Knights working together in their Guilds, according to the Oaths which they took in their Temples, and then working together under the direction of their Guild Leader, like the Jutes who established London did and still do, that Corruption had Knights making their Oaths to other men, instead of to God.

That happened as follows:

a. The Knights of an area, a Tenship, would go to the Leader that the Enemy had appointed over them, and make their Oath to him. The Enemy named this man, a "Baron," over that Tenship. The "Oath," in Latin, was, "I will bear my Faith unto you." That is, this "Knight" would no longer become a Knight, as among the Free Men of the Jutes, by going to his Temple and covenanting to "bear his Faith to God," like the Early Christian Jutes did, but, instead, went to another man and said that he would "bear" his "FAITH" to that other mortal man. That "Oath," in Latin, was: "In tibi fidem portabo." The Baron would cup his hands, as the "Knight" put his hands together, in the Roman Catholic manner to pray, as he, then, put his "praying hands" into the Baron's cupped hands, and then said the above "Oath."

[Among the Romans if a person would do work for Caesar when he had no Coins to pay him with, it was said that that person was worshipping the minor Roman godlet, Fides. That word, "fides" is the origin of the English word, "faith." Medieval Italians had begun pronouncing that word, "fede." The Dutch-speaking leaders of the Franks, trying to say, "fede," would say, instead, "feud." This is the origin of the "Feudal" System. It is also, linguistically, the origin of the concept of a "Federal" Government.]

b. The Baron would have previously said that and done that with his "praying hands" to the person whom the Enemy had put over the Germanic "Hundred," in which

they lived. That person had been designated a “Count”; and the designation, “Hundred,” was often changed to, “County.”

c. The Count would have previously said that and done that with the person whom the Enemy had put over the Germanic “Shire,” in which they lived. That person was designated a “Duke”; and the designation, “Shire,” was often changed to, “Duchy.”

d. The Duke would have previously said that and done that with the person whom the Enemy had put over the Germanic “Land,” in which they lived. That person was designated the “Monarch,” over the “Realm” that that Land had been designated to be.

3. Previous to having been able to do the above they had first needed to set up the Realm that was at issue. “And, how did they do that?” In this Frankish Realm, in what had been Gaul, but was by then thought of as France, the population spoke French. The French way of saying the Latin word, “Gubernum,” was, “Government.” So, the way that the Enemy set up this first “Government” among the Nordic, Christian, European People was the way that all of the “Governments” were set up that became the feet of Iron mixed with Miry Clay which the Stone would hit that would destroy forever the Great Image of the Governments of all of the World that descended from Babylon.

“So, how was it that that first Government was set up?”

It was done by the Enemy through the Conversation, that will now be reviewed, about how to Trick everybody in the World to Work Together in the Babylonian way. It had to begin with the essential TRUTH about Mankind, but then it proceeded with this attempt to Trick all of Mankind into working together in the Babylonian way. As all of the Human Race sees, on the Modern Internet etc., the Insanity of this Trick and they turn their backs on it, as just so much Insanity, then that Insanity – which had served as the Wisdom of the World’s Wise Men to trick everybody in the World to work together in the Babylonian way – will PERISH, as Mankind will have nothing more to do with it.

As that Conversation is concluded the dynamics of the information that has been written here will have been presented. And, that will then provide the opportunity to present the Purpose for writing this Information. That purpose is, with the Trick with which Mankind has been tricked for Centuries exposed and put aside, by all of the People in the World, the subject will have been brought up for all of Mankind, “What is the essential TRUTH about Mankind?”

That is the Information with which this writing will conclude. A way to approach that Information is to consider how it was that that Conversation began, that those who had it felt would trick everybody in the World. That is the subject that will be considered after a review of this next subject, that which is known about “the essential TRUTH about Mankind,”.

Let us now review these Truths.

In the Book of Job the Prophet Job was told that, “All of the Sons of God shouted for joy,” when they heard that they were going to be able to come down to this Earth and live here, Job 38:7.

Latter-day Saints are told: “This is my work and my glory – to bring to pass the immortality and eternal life of man, Moses 1:39.”

So, the Purpose of Humans being here on the Earth, for the Opportunity to attain which Purpose all of us shouted for joy, is the “opportunity” which each of us has of achieving this, God’s Purpose for our being here.

However, in the New Testament the Lord said, “Strait is the gate and narrow is the way which leadeth unto life, and few there be that find it, Matthew 7:14”

So, even though “all of the sons of God shouted for joy” for the opportunity to be able to accomplish this Purpose of God for our being here, there will be “few” that even “find” the strait gate to the narrow way that leads to “eternal life.”

If asked what that Strait Gate is, that virtually no one ever finds, it is obvious what it is.

In the New Testament the Lord said, “All the Law and the Prophets” “hang” “on” “two Commandments, Matthew 22:40.” The Second was like the First. “The First and Great Commandment, Matthew 22:38” contained: “Thou shalt love the Lord thy God with ... all thy mind, Matthew 22:37.”

Latter-day Saints know that the Eternal Intelligences, the Minds, of all Humans, came to God as He and our Heavenly Mother begat our Spirit Bodies in Heaven. We all loved our God with all of our Minds at that time. The Issue was to come to Earth, get physical bodies, and show God that we still loved him that way while here, as each finds that Strait Gate and Narrow Way to love Him with all of our Minds, here on the Earth. 2/3 of our Heavenly Parents’ Spirit Children “shouted for joy” for the opportunity to be able to so continue. 1/3 did not want to and became devils because of that refusal.

“And, here on the Earth, how is it that one loves God with all of one’s mind?” In the 1,000-page Course it says that Billy Graham or the Pope might look at someone like that person was out of his/her mind if either of them were asked how it is that either of them loves the Lord their God with all of their minds. To them and to just about any other Human who has heard of that First and Great Commandment, it might sound like an impossibility. However, all LDS know that “the Lord giveth no commandments unto the children of men, save he shall prepare a way for them that they may accomplish the thing which he commandeth them, 1 Nephi 3:7.”

An LDS person might reason that, “if ‘the Lord giveth no commandments ... save he shall prepare a way ... that they may accomplish the thing which he commandeth’ then He, most certainly, has prepared a way to keep this First and Great Commandment.”

“Is that ‘way’ spoken of a lot among LDS people?” Every little child in the LDS Church knows how he/she is to love God with all of his/her mind. Almost every Sunday each one of them promises their Heavenly Father that they “do always (there is the all part) remember (there is the mind part) him, D&C 20:79,” the Son of God. If Investigators ask how that gets them through the Strait Gate and Narrow Way, they are told that, “they may always have His Spirit (the Holy Ghost) to be with them, D&C 20:77.”

So, LDS People know that if they keep the First and Great Commandment and love the Lord their God with all their minds, if they will always remember His Son, they may have the Holy Ghost to always be with them, to show them how to find the Strait Gate and proceed on the Narrow Way that leads them to Eternal Life.

And, LDS People know what Eternal Life is. It is to have the same Eternal Procreative Powers that our Heavenly Parents have, to help them in the Work and Glory of God, to bring to pass the Immortality and Eternal Life of Man, and to procreate, as they do, Spirit Children.

The question that is ever before an LDS person, who feels the Holy Ghost leading through that Strait Gate and along that Narrow Way, is: “Am I loving the Lord my God with all of my Mind so that I am following the way that God prepared for me to have these Eternal Procreative Powers that my Heavenly Parents have?”

That is the Strait Gate and Narrow Way that is known by those who are fortunate enough to be the recipients of the Blessings of the Restored Gospel and its Message to each of them about this, the “Essential TRUTH about Mankind.”

“However, what about all of the rest of Mankind?” It could be that virtually all of Mankind have “heard about” the Strait Gate and Narrow Way “that leadeth to” Eternal Life. However, it may be that almost all of them sense that maybe they really don’t have any chance at all of ever finding it.

LDS People know that every child is born in a “Celestial” Communication with his/her Heavenly Parents, and that this “Celestial” Communication lasts until that child is eight years old. That “Celestial” Communication is our “Conscience” that all of us have up until eight years of age; and it remains there, in some condition, for all of God’s children, for the rest of their Lives.

Let us now consider how the Enemy abuses this information, concerning “the essential TRUTH about Mankind,” to form the Governments of Babylon. This is, basically, the History of the way that that Enemy has formed these final, Iron mixed with Miry Clay, Governments of Babylon by abusing Mankind’s Consciences.

Here is a sample of what could be the Conversation of the Enemy that formed these Final Governments of Babylon.

“Men and women have Consciences. They sense, perhaps most weakly, what they covenanted with their Heavenly Father and Mother about how they would work, with their Minds, here in the World. Their Consciences tell them how completely they are failing to allow their Minds to work like the Minds of their Heavenly Father and Mother, for their Heavenly Father and Mother. With this very sad information from their Consciences they feel very sad, which is a very bad way to feel. All of them want to bring these bad, sad Feelings to an END. We will do that for them. We will build this Final Type of Babylonian Governments on that word, ‘END.’”

In French, that English word, “end,” is said “fin.”

“How did Medieval Governments arrange to bring People’s bad, sad, Feelings, their ‘Guilt’ Feelings, to an ‘end,’ a ‘F-I-N,’ in Medieval French?”

They would pay an “F-I-N-E,” in Gold Coins.

“Who would they pay the FINE to?”

The “First Monk.”

“What does that mean?”

The way that one says, “first,” in French, is related to the word, “Primary,” in English. In English a “Monk” is a person from a “Monastery,” called a, “Minster,” in Medieval English.

Oh, I get it. The FINE is paid to the Prime Minister. “Why pay the FINE to the Prime Minister?”

Because he is the “Cancellor”; he has the ability to “cancel” one’s Sins.

“How in the World does that happen?”

One can see this Procedure still operating, as it operated to begin that first Medieval “Government,” in France, in any current Roman Catholic Cathedral.

For a lot of Protestants, who may not have had much contact with Catholic circumstances, a way that this might be introduced is the way that Billy Graham used to conduct his Revivals in large circus-type tents after World War II.

It seemed expected that the Tent would have a high ceiling. The chairs would be arranged so that there was an aisle down the middle. In a certain part of the ceremony all of those who wanted to be saved from their Sins would, stand up, move over to the middle aisle and walk down to the front of it where Billy Graham was standing. It was understood that their Sins were leaving them as they stood up and moved forward. When they got up to the front Billy Graham whispered something in their ear; and they would

react by throwing their arms up into the air and maybe shouting, because now they were saved from their Sins.

This is a Southern Protestant adaptation of that type of a ceremony in Medieval France or at a current Roman Catholic Cathedral. The following are the elements of the procedures that are involved.

If a person feels that he/she has committed Sins, he/she goes to a Confession. At that Confession that person is told how much of a FINE to pay in order to have those Sins cancelled. To begin this procedure that person goes to the building that is often near the Cathedral. In English it is called a "Chancery." However, if the information is also available in Spanish, one will see that it is the "Cancelaria"; it is where one pays one's FINE to have one's Sins cancelled. When Adolf Hitler took over the Government of Germany, to become its "Prime Minister," in English, he became the "Kanzler" of that Government, in German. Apparently the Enemy got into trouble in England by having the people told to go to the "Canceller" to have your Sins "cancelled." But, they still say it the original way in German and Spanish.

So then, once one has gone to the Cancellor and paid the required FINE to have one's Sins cancelled, that person is able to go into the Mass to participate. The building normally has a high ceiling, like Billy Graham's Tent. And, the benches are arranged so that there is an aisle down the middle. Then, at a certain place in the ceremony all of those who want to have their Sins Cancelled stand up, move over to the middle aisle, and then walk down to the front. Instead of Billy Graham standing there, a Monk is there.

He has a plate of bread soaked in wine. Then he says something about that. In Robin Hood's day he and his associates thought that the Monk was saying, "Hocus pocus." What he is saying, in Latin, is: "Hoc est corpus Christi." In English that would be translated to be, "This is the body of Christ." What the Monk is telling the people is that the bread and wine are being CHANGED, to become the actual flesh and blood of Christ. Then, as they eat it, it changes their bodies to become the actual flesh and blood of Christ, which is completely sinless. The whole System is dependent on the people believing that this actually happens, so the entire System is set up to get people to think that that is what happens.

The System begins in Rome at a large hole in the ground in the Vatican Cathedral. In the bottom of that hole is a dead body. Those involved in this System allege that it is the dead body of the Apostle Peter. It is not. Peter, in his resurrected body, along with James, in his resurrected body, and John, in his translated body, were all sent to lay their physical hands on the heads of Joseph Smith and Oliver Cowdery to give them the Melchizedek Priesthood and ordain them Apostles. That body down in the bottom of that hole is just the dead body of some long dead Italian. If its d.n.a. were tested there would probably be no way that it could be of Peter's ethnicity.

However, that System is based on that dead body giving out all of the Correct Hunches that are needed to run that System. It is said that, at times, above that dead

body, at ground level, at the top of the hole, a chair is suspended out over the hole. That Chair is called, "Peter's Chair." It is held that, because those Correct Hunches come straight up from that dead body, right into that chair, that person, sitting in that Chair, is, "infallible," that is, in that Chair, his Hunches will always be Correct Hunches. Sitting in that Chair that person then "transmits" those Correct Hunches upward, to go up, through the Dome of St. Peter's Cathedral and up and out of the Rod that is sticking out of the very top of the Dome. From there those Correct Hunches are transmitted all over the World. This Transmission of these Correct Hunches may be thought of as being like a flock of speediest birds, flying in search of other Cathedrals. When one is spotted, it is as if one of the Correct Hunches says, "Let's go down there." Once they get to the Rod poking out of the top of the building they "transmit" themselves, down through it. Now they are in the Dome of the Cathedral, its necessary High Ceiling. Once there they immediately dive for the plate of bread soaked in wine. They have come, so to speak, straight from St. Peter's dead body to that Plate of bread soaked in wine and changed that bread soaked in wine into the actual flesh and blood of Christ.

It is one thing for the Monk to say what sounded like, "Hocus Pocus," to change that bread and wine into the actual body of Christ. And it is another thing for this ceremony to take place in the environment that it does. But, that was not felt to be enough. Something more, something believable was needed.

It was felt that that something more, of believability, would be accomplished if another Monk, standing behind a screen, out of sight, hit a little chime, to make a "TONE," at the exact instant when the Correct Hunches came down through the roof, all of the way from St. Peter's dead body, and changed the bread and wine into the actual flesh and blood of Christ's body.

That seemed to be what was needed. The people of Europe came to feel that, "At The TONE Of That TONE, They Were A-TONED." In Medieval Norman French the way that one says, "at," is, "a." Again, the Message was: "At" that precise moment that they hear "The TONE Of That TONE," those taking that bread and wine are "A-TONED"; "ALL of their Sins have been CANCELLED by this A-TONE-MENT."

In Germany and Scandinavia, where Norman French has had much less influence than it had in England, the way that the "A-TONE-MENT" is expressed is the "For-Sound-Ing," said as, the "FOR-SON-ING-EN," in Swedish.

Among other things, because so much of the original Law of the Lord's Gospel endured in England, the System had to try to cover up some of this that has just been mentioned. They tried to say that the message of the expression, "The 'Atonement' of the Lord Jesus Christ," is only a surviving Anglo-Saxon expression meaning the 'at-one-ment' of the Lord Jesus Christ." This is what is found in dictionaries that do what the System tells them to do. The fact of the matter is that the Monks who came to England, in the company of the Norman French, were totally committed to throw out everything that they could of the surviving Anglo-Saxonisms of the English-speaking People, in relation to their "Ancestral Adherence" to the Law of the Lord's Gospel, that is, to their

adherence to the Traditions which they had inherited from their Forefathers who had founded England. One expression that they couldn't get rid of, although they threw it out everywhere else in Europe, except in the British Isles and in the Scandinavian Isles, was the word, "Gospel." However, to leave an Anglo-Saxonism in, as an expression, at the essence of their System, was not the way that the Norman French Monks operated. The word, "Atonement," is not an Anglo-Saxonism. It is the Official Norman French, Roman Catholic Doctrine for the Cancellation of the Sins of a FINE-payer. It happens "at" the "TONE." Again, the word, "at," in French, is "a." The word, "A-TONE-MENT" means what happens "AT" the "TONE." And, any Linguist will tell one that the suffix, "-MENT" is French; it had nothing at all to do with Anglo-Saxonisms.

"What is the result of all of this FINE paying, arranged by that first Organization, in Medieval France, that was the First "Government," for having all of the Christian People of Europe pay their FINES to their First Monk, their Prime Ministers, their Cancellors, to Cancel all of their Sins and bring all of their Guilt Feelings, that their Consciences had, to an "End," a "FIN" in French?"

It is the way that all of the "Governments" of the World have been run thereafter.

"You mean to say that all of the 'Governments' of the World conduct all of their Operations by something that comes from them 'FIN-ing' people, making them 'pay 'FINES'" to those Governments?"

You said the word, "FIN-ing." In the French Language we show the addition of the English suffix, "-ing" by adding on the French equivalent for that English suffix. Our French suffix for that is: "-ance."

By my giving you the history of the origin and operation of the System of these Last "Governments," of the Great Image of Babylon, for FIN-ING the People of the Nordic Christian Lands of Europe, you have been shown the origin and operations of the "FIN-ANCE" that all of the Governments of the Planet Earth base All of their Operations on at this time.

The Issue

This Information that is written in this Synopsis is available, in an “expanded” form, in the 1,000-page Course.

As the conclusion to this Synopsis, it may help to briefly state some summaries of some of the main topics that have been considered in it.

In referring to Daniel’s Prophecy, there are many things that, for many decades, have been included in the messages that LDS missionaries present.

That Prophecy that, “in the Latter Days,” “in the days of these kings shall the God of heaven set up a kingdom, which shall never be destroyed: ... but it shall break in pieces and consume all these kingdoms, and it shall stand for ever, Daniel 2:28,44,” has been a frequent part of LDS Missionary messages.

Before going on their Missions, in their childhoods and in Seminary and Institute Classes, LDS Youth learn, in the “Doctrine and Covenants,

101:77. According to the laws and constitution of the people, which I have suffered to be established, and should be maintained for the rights and protection of all flesh, according to just and holy principles;

78. That every man may act in doctrine and principle pertaining to futurity, according to the agency which I have given unto him, that every man may be accountable for his own sins in the day of judgment.

79. Therefore it is not right that any man should be in bondage one to another.

80. And for this purpose have I established the Constitution of this land, by the hands of wise men whom I raised up unto this very purpose, and redeemed the land by the shedding of blood.”

When they return from their Missions and take College History Classes, they read where it is said that the American Revolution sparked the French and Russian Revolutions. After reflecting on these things, it then comes to seem like, today, all of the Kingdoms, Empires etc. of Europe, the Iron mixed with Miry Clay of Daniel’s Prophecy, that seemed to have originated out of the Romans’ Empire, have all seemed to have been replaced, today, by Republics based on Written Constitutions, that are, theoretically, based on the “just and holy principles” of “the Constitution of this land,” that “the God of Heaven” “established.”

So, the thought of the “Kingdoms of Babylon” all being overthrown and replaced by “a Kingdom” that is “set up” by “the God of Heaven,” is information that many Returned Missionaries taking College Classes on Modern History encounter in a way that they may reflect upon it quite frequently.

“But, what about the ‘Trick’ that ‘the Enemy’ plays on the Human Race, ‘to Trick all of Mankind into working together in the Babylonian way’?”

That may be answered, somewhat, by some of the things that motivated the writing of the first parts of the 1,000-page Course that were written.

In 1972 the Author of the 1,000-page Course talked with the Immediate Past President of BYU about the beginning of the BYU Law School, that that Immediate Past President was involved with. The Author brought up the subject of the Story of the origin of the ancient Scandinavian and Anglo-Saxon word, “Law,” as contained in the Icelandic Sagas. He was urged to take some actions which resulted in the writing of two of the first Books in the 1,000-page Course.

Then, in the Summer of 1973, he met the renowned LDS Author, W. Cleon Skousen. When the latter heard of those two first Books and the Story that accompanied them, he related the following information:

“A few years ago (in 1967) President McKay called me into his Office. He said, ‘Because of the work that you and Elder Benson have done for our Government (President Ezra T. Benson had been the Secretary of the US Dept. of Agriculture and Brother Skousen one of the leading Administrators in the FBI), I am giving each of you an assignment.’ Then he said, ‘Brother Skousen, our people are becoming slaves. They are falling for the same old Lures and Tricks that all of the rest of the World is. I want you to go down to Provo and work on how our people can work together by the Law.’”

Then Cleon said, “I asked him, ‘Can’t the University do it?’ He answered, ‘No, they don’t have the vision.’ Then I asked, ‘But, what can I do?’ Then he prophesied to me, ‘You go down there, and the way will open up!’”

Then Cleon said, about the Author’s work on the Scandinavian origin of the word, “Law,” and about its early history in Scandinavia, “You know, I think that this is it!”

Hearing that President McKay had made such an important Prophecy concerning the coming of his work, on this Subject, the Author felt obligated, during the mid 1970’s, to pursue developments that produced more of the 1,000-page Course. However, in late 1978, when the Wall Street Journal and the International Press acclaimed the development of his “New Learning” Language Analysis Methodology to be the Invention of the “Cost-effective Machine Translation” of Human Languages, that, in the BYU Project of the 1970’s, was to allow for the development of the “Fully Automatic Machine Translation,” that would permit the people of Utah to begin the operation of the Worldwide Interlingual Telecommunications Utility, that Presidents McKay, Kimball and Brown had prophesied would allow the Church to make it so that, “Every man shall hear the Fulness of the Gospel in his own Tongue, D&C 90:11,” the Author knew that he had to complete the 1,000-page Course, as mentioned at the beginning of this Synopsis.

In the 1,000-page Course, the dirty, little Trick, that enslaves the World, to work for the current Leaders of the Babylonian Way for Mankind to “work together,” is addressed in the detail that many have felt will show everybody in the World that that Dirty Little Trick, which those current Leaders of the Babylonian Way for Mankind to work together continue to herald as, “the Wisdom of the World’s Wise Men,” is nothing more than that Dirty Little Trick, from which all of Mankind will uniformly turn away in

disgust, thus resulting in the movement that makes it so that: “The Wisdom of their Wise Men Will PERISH!”

The 1,000-page Course was written for the LDS Persons who will need to understand things that it contains in order to begin and then operate the Worldwide Interlingual Telecommunications Utility, which LDS Church Presidents persisted in their commitments to see developed after, it seems, so many others had given up. This Synopsis has been written and, perhaps, more may be, to allow the friends, associates, family members, etc., of those Persons, who go through the 1,000-page Course, to understand some of the principal things that it addresses without needing to do the reading, perhaps classes, etc., that may be involved for those who take the Course.

It is understood what the reaction of many might be in reading this Synopsis, to this point. Many persons might wonder, “Hey, wait a moment. What is going to happen to the Economy of the World, with me in it, when these ‘governments,’ that gave the World the Concept of operating on Gold Coin ‘Money,’ are ‘carried’ ‘away’ by ‘the wind,’ ‘that no place was found for them’?”

Many of the answers for such questions are found in the 1,000-page Course. However, here, let’s talk about the basics of how the Worldwide Adoption of the Ancestral Free Enterprise System, of the Anglo-Saxon and related Peoples, works, today.

As mentioned earlier, during 1997 the World Market bought and sold 15 Trillion Dollars worth of this Anglo-Saxon Concept, with this Anglo-Saxon name, “Stock” or (to use the ancient Anglo-Saxon name for “Voting Stock”) “Wealth,” every day on the “Utah Invention” of the Internet. That amount times 250 Work Days a Year = 3.75 Quadrillion Dollars every year. The London Bond Market sells as much, in the Anglo-Saxon Concept and Word of, “Bonds,” in 70 days, as all other Bond Markets and all Stock Markets do in a year. That is, not taking into account any other Bond Markets, with the London Bond Market selling as much in Bonds in 70 days as the World Stock Markets do in 250 Work Days, that means that the London Bond Market sells 3.57 times 3.75 Quadrillion Dollars in Bonds, every year. That is, \$13,387,500,000,000.00 or almost 13.4 Quadrillion Dollars, in Bonds, every year. That amount, divided by a World Population of about 6 billion, equals \$2,291,250.00, or, almost 2.3 Million Dollars, for every person in the World, every year.

That is the way that the Modern World operates.

“Where did those 500,000 London Free Men get the Fortune to run the World like that?” Their Forefathers, the “Jertti Knights,” brought it with them as they built a Temple to the Lord to be at the Center of their Capital City, London, when they first established it, in, about, 450 AD. By the Oaths that they have always taken in that Temple, since that time, to “Work Together by the Law” of the Lord’s Gospel, each of them has always earned, as his “Wealth,” his “Voting Stock,” ALL that he has produced according to his Temple Oath. These Millions of London Free Men, over the Millennium and a half that they have been there, doing that, have acquired this Amount of WEALTH for themselves,

that allows them to provide these Services for everyone in the World that they have been providing these Services for, for all of these many Centuries.

“How do we know that they have ‘been there, doing that’ for all of that time?”

Article 13, of the Magna Carta, says that as long as they keep doing their Business there according to the “Ancient Liberties and Free Customs” that their “Jertti Knights,” Forefathers, brought there with them, when they began doing their Business there that way, in 450 AD, the Monarchs of England and all of their Feudalistic Followers had to stay out, outside of the Castle Walls of London, unless one of them was especially invited in. If one is, let’s say that it is the Monarch, that Monarch has to come to a place out in front of the Temple, at Temple Bar (named for the “Barricade” that used to be there, that “barred” the Monarch and all other Feudalists from coming into the “Commonwealth” of London) to be formally invited in, as the personal guest of the Leader of the London Free Men, the President of their Temple, known today as, “the Lord Mayor.”

“And, what was to stop the Monarch and that Monarch’s Feudalistic Army from conquering that City/Commonwealth?” That City/Commonwealth’s Navy, later named, “the English Navy,” that always headquartered there at London, which was always far more powerful than any Monarch of England’s comparatively tiny Feudalistic Army.

“But, how will any Americans be able ‘to work together by the Law’ of that Ancient Commonwealth?”

It was that Commonwealth’s Navy that established New England. The Settlers of the Commonwealths of Connecticut, Massachusetts, etc. did everything that they could to set up their Commonwealths so that the impoverished Natives of the Americas could have access to the Highest Standard of Living of the World, like the Lord Jesus Christ had instructed their Forefathers, who began London, to always be able to have, by adhering to their Temple Oaths to obey the Law of the Lord’s Gospel. For the first 200 years of their being here, all of the Forefathers of the New Englanders became “American Free Men,” as they invited all Native Americans to also do, by taking their Oaths on Law Sunday, the First Sunday of each Month, in their Township’s Church Meetinghouse, to pursue the Goals of the Particular “Constitution” of their particular Commonwealth. (The People of New England are the Inventors of the World’s First “Written Constitutions” and those from which the whole rest of the World got the idea to try to copy them.)

After the Yeomanries of New England, as the newly formed US Army, won the American Revolution, they were tricked into writing a US Constitution that included the Southerner Slaveholders, who did not believe in the Law as had been lived by London’s Free Men. Those Southern Slaveholders and those from whom they were descended were, basically, the proponents of Feudalism in England and America. After the Southern Slaveholders had tricked the New Englanders to include them in their “New England Ancestral Type of a Constitution,” those Slaveholders immediately challenged the New Englanders to show them how Jesus Christ had ever shown their Forefathers in

London how to “work together by the Lord’s Law.” The New Englanders couldn’t. They “fell to pieces.” And, Southerners, basically, took over running the USA down until the Civil War.

When “the Constitution State of Connecticut” (that wrote “the World’s First Written Constitution”) had to formally admit, in 1818, that it did not know of any connection between their Ancestral, London way of Working Together by the Lord’s Law and the Lord Jesus Christ and then terminated all formal supports for New Englanders trying to keep following that way of doing things, such as the many New Englanders who had settled in Upstate New York, a young New Englander there began searching to understand what should be done. When he was 14 years of age he went out into a Grove of Trees near to his home to ask his Heavenly Father what he should do.

His Heavenly Father and the Lord Jesus Christ appeared to him and told him that they would tell him what to do.

After he had grown up and was instructed as to how the Church of Jesus Christ of Latter-day Saints should be organized, it was so organized, and then began to grow, this young man and his associates wondered how they should try “to work together by the Law.” In his answer he was told the following:

“Doctrine and Covenants 86:8. Therefore, thus saith the Lord unto you, with whom the priesthood hath continued through the lineage of your fathers –

9. For ye are lawful heirs, according to the flesh, and have been hid from the world with Christ in God –

10. Therefore your life and the priesthood have remained, and must needs remain through you and your lineage until the restoration of all things spoken of by the mouths of all the holy prophets since the world began.

11. Therefore, blessed are ye if ye continue in my goodness, a light unto the Gentiles, and through this priesthood, a savior unto my people, Israel. The Lord hath said it. Amen.”

This young man was a member of the Family of the Patriarchal Line of Mankind. It was revealed to him, about his wonderfully handsome Oldest Brother, who would have been the Second Patriarch of the Restoration, had he not died from Medical Malpractice: “My older Brother, Alvin Smith, was the Handsomest Man Who Ever Lived, after Adam and Seth.”

In the above quoted Scripture in the Doctrine and Covenants the Lord Jesus Christ tells the evil Southern Slaveholders – who had never lived the Rules that had always been required of New Englanders to become “American Free Men” – how those New Englanders that He called to organize the Church of Jesus Christ of Latter-day Saints, were “lawful heirs” of the “priesthood,” “through the lineage of your fathers,” “according to the flesh,” “and have been hid from the world with Christ in God.”

The Forefathers of those who settled New England, to become its “American Free Men,” who were the descendants of the London Free Men of the “Guild” of England’s Fishermen, who were descended from the “Jertti Knights,” who started and organized London around their Oaths to work together by the Lord’s Law – that they had always taken in the Temple of the Lord, one of which they had built in London, starting, perhaps in about 450 AD, and then around which they had built the rest of London’s Commonwealth – had all been “hid from the world with Christ in God.” This did not apply to the Southern Slaveholders and to their feudalistic fathers, who had come to England many centuries later, from Normandy, France etc., to become the “Feudalistic Slaveholders” of rural England’s peasantry, after the Norman Conquest in 1066 AD.

Those Feudalistic “Slaveholders” of rural England’s Peasantry, who first came to England in 1066 AD and thereafter, knew nothing of the way that the “Jertti Knights” and their Descendants, in London, had always taken their Oaths, in the Lord’s Temple, to work together by the Lord’s Law, since they first came to England in 450 AD. As relates to the rural Feudalistic “Slaveholders” of rural England, and to all other followers of such Evil Practices, those “Jertti Knights” and their Descendants, the Free Men of London and the American Free Men of New England, had been “hid from the world with Christ in God.”

So, when those of their Lineage, who had come to New England and through whom the Church of Jesus Christ of Latter-day Saints was restored, asked their Father in Heaven how it was that they should “work together by the Law,” they were told, “blessed are ye if ye continue in my goodness.” [Among other things, they were to have nothing to do with the Southerners’ way of doing things, since, as the Lord said: “It is not right that any man should be in bondage one to another. And for this purpose have I established the Constitution of this Land, by the hands of wise men whom I have raised up for this very purpose.” And, of course, as anyone knows who will just read its History, the Constitution of the United States of America was written by the “Connecticut Delegation” to the Constitutional Convention, as “the Connecticut Compromise,” not by Southern Slaveholder Tricksters, whom their Propaganda lies are the “Founding Fathers who wrote the US Constitution.”]

The Church of Jesus Christ of Latter-day Saints did “continue in my (the Lord’s) goodness.” They organized themselves to continue to “work together by the Law,” just as their “Fathers” had done, in their Temple in London, from 450 AD (and as some of their Forefathers’ Descendants, there in London, have continued to do there until now, in 2005 AD), and as Members of the Church have always continued to take their Oaths to do, since then, in their Temples. However, when this Group of Americans, in the Restored Church, continued to work together by the Lord’s Law – in the face of the Southern Slaveholders’ jeering at all other Americans, that they knew Nothing about their “Gospel Rights” (that their “fathers” had always gotten in their London Temple, as they became London Free Men, but which Southern Feudalistic Slaveholders now began to say were “their ‘Civi-l’ Rights,” which their Feudalistic Forefathers got from the Gubernum of the “civi-tas” = “City” of Rome,” which meant that those “Rights have no

dependence on our Religious Opinions”) – in the face of that Southern jeering, that had overwhelmed so many other Northerners, persecutions came to the Restored Church.

It may have been that most of those who murdered their Prophet were Northerners who had been overwhelmed by the Southerners’ Jeering. However, it may have been that there were a number of Southerners among those Murderers as well.

The Restored Church had to leave a USA overwhelmed by that Southern Jeering.

They came to Utah, to continue the Church’s growth here. As they promised their Heavenly Father in their Temples, that they built here, that they would do, they continued to “work together,” in Utah, the way that their Fathers had always worked together by the Lord’s Law in the Guilds of London in England. The renowned LDS Historian, Leonard Arrington, who served as the Church’s Church Historian, wrote this in his Book, “The United Order”: “In Salt Lake City, the United Order of Tailors and the United Order of Tanners were just a continuation of the English Guild System.”

In Territorial Utah the Latter-day Saints were able to “continue in” the Lord’s “goodness,” in their United Orders, working together by the Lord’s Law, as they promised the Lord that they would do in their Temples, just as their “Fathers,” in London, “hid from the world with Christ in God,” behind the Temple Bar barricade against the Feudalistic fathers of the Southern Slaveholders etc., have done there till this time, allowing themselves to accumulate so much of their Anglo-Saxon “Wealth” there that they operate the Finances of all of the World’s Central Banks today from there.

However, even though the USA was able to win its Civil War against its Confederate Betrayers (who were allied with Britain and France during the US Civil War, to help those Countries conquer the USA, see “The Story of Rights in America”) the People of the USA, till this day, have not been able to escape from their having been overwhelmed by that Jeering of the Confederate Slaveholders, jeering at them, that they think that their Ancient, Ancestral “Gospel Rights” (that they had called with – and their Forefathers, in London, New England etc., had ALWAYS called with – these two Ancient Anglo-Saxon names, “Gospel” and “Rights”) are that, which Rights, again, are those which they had inherited from their “Jertti Knights” Forefathers as they established London during their Conquest of the Romans’ Empire.

Since Romists took over all Learning during the Middle Ages, except within the Commonwealth of London, their Romist Story of Things has been the only Story of Things that has been available to the General Public until this, The Information Age, operating on its Utah Invention of the Internet, etc. That Story, of the Romists, is that everything Good in Human Society came from Roman Society. However, in today’s Information Age – when all Information, under the microscopes of the Information Age, will show everybody in the World, who wants to know, that the ENTIRE preoccupation of the southern Italian Peninsula, during the Centuries BC and AD of the European Gold Coin Trade there, was the lowest human degradation imaginable, that allowed those who controlled the Ground, that that Gold Coin Trade of Western Europe operated over,

which was the southern Italian Peninsula, to extract all of those Gold Coins that they could from those Merchants and, then, “Tourists” etc., which lowest degradation imaginable made the name of their Heathen Idol, Moneta or Money, the name which nearly every member of the Human Race, at this time, finds as the name that is consuming nearly “all of” his/her “Mind” – a very different Understanding, that can become a worldwide understanding, seems to be near.

However, even though it was after the US Civil War, the rest of the overwhelmed Americans told The Church of Jesus Christ of Latter-day Saints, in Territorial Utah, that they could not become a State in the USA until they gave up the Ancient, Ancestral Law of their Forefathers, in New England and London, of working together by the Law of the Lord’s Gospel, which Southern Slaveholders had wrenched out of the hands of all other Americans with their Trick that they pulled of getting the Benefits of the New Englanders’ “Constitutional Law” even though none of them had ever qualified for it, by the Ancestral Rules for getting those Benefits.

Because of that, even though all Latter-day Saints still all obligate themselves to work together by the Law of the Lord, as they take their Oaths to do that in their Temples, the only Latter-day Saints in relation to whom their Government has never interfered with their “Working Together by the Lord’s Law” are the Latter-day Saints of the LDS Colonies in Mexico.

“What good does that do us?”

To begin the Worldwide Interlingual Telecommunication Utility, the main thing that is needed are the Services of the World’s Foremost Experts on the Complete Human Language Technology of the English and the Spanish Languages. Those people are the thousands of Graduates from the Church Education System’s Double-load Education, in the LDS Colonies in Mexico.

Beside being so Technologically Superior to their current “competitors,” of the London Translators Guild, who currently monopolize the type of work that will begin the Worldwide Services of the Utility (“technologically superior” because these LDS Colonist Graduates are all able to go from Perfect, Native, Educated Spanish to Perfect, Native, Educated English and back), these Colonists also have the exact same Essential Ancestral Law of the Free Enterprise System, that the London Free Men of the London Translators Guild have, the absence of which, among any others, of that Essential Ancestral Law, the London Translators have held excludes any competitors to them from qualifying for the Enormous London Bond Market Performance Bonds, which are required for people to gain access to the World’s Most Valuable Trade Secrets, of the World’s Largest Corporations, which are understood are to be almost all of the Customers of the Worldwide Interlingual Telecommunications Utility that will be the ones that will “put it in Business.”

So, that is not so in this case. Beside the Colonists being the Technological Superiors of their would-be “competitors,” in the London Translators Guild, they have

always had the EXACT Same Ancestral Heritage of the Essential Ancestral Law of the Free Enterprise System that the London Translators Guild has always operated on, as it qualifies for the Quadrillions of Dollars Worth of London Translators Guild Performance Bonds from the London Bond Market. The Colonist Translators qualify in the EXACT same way that the London Translators do.

What is more, as other LDS Translators, who translate for the Church into and back from the nearly 200 other Languages that it translates (into and back from the World Language of North American English), apprentice to and then join the Translators Guilds begun by the Colonists, and learn from them how they, as well, can use their Temple Oaths to so organize their Lives so that they will also qualify for the Largest Performance Bonds in the World, there will quickly become more Latter-day Saint Translators, in the USA and around the World, qualifying for these Quadrillions of Dollars of Performance Bonds, than there are Translators in London. “So what?”

The poverty-stricken “Countries” of the poverty-stricken World are in the situation that they are in for one reason. Their “Countries,” still operating on the Medieval Money Systems of the Medieval “Realms” of Europe, are still so poverty-stricken because of that fact that they are still operating on those Medieval Money Systems, which are still operated by the same type of Tricksters that operated those Medieval Money Systems of those Medieval Realms.

“How does the LDS Church’s United Order’s Way of Working Together, by THE LORD’S LAW, get people away from that Poverty?”

In the LDS Church’s United Order (that has been continuously practiced among the Latter-day Saints who are Colonists, to this day) what our LDS People make their Covenants to do for the Lord’s Work, in our Temple there in the LDS Colonies, may qualify them to receive the guidance from the Holy Ghost on what they are to do to achieve that. As they get that Guidance from the Holy Ghost, THE RESULT OF THEIR WORK “HAS ALWAYS BEEN THEIR STEWARDSHIP,” IN THE UNITED ORDER OF THE LDS CHURCH. “What does that mean?” It has always meant that whatever they thus do continues to be THEIR “WEALTH,” THEIR PROPERTY, not the Property of some Romist Trickster.

“How was it that that gave the People of the Germanic ‘Countries’ of Europe, consistently, ‘the Highest Standard of Living of Any People in the World’?” That is easy to answer. Since they weren’t “Realms,” “Countries” that were run by Romist Tricksters, which Romist Tricksters were continuously out to rob everyone that they could of all that they could get from them, thereby impoverishing those “Realms,” every Land of the Germanic Peoples was called a “RICH,” where each Worker GETS TO KEEP ALL OF HIS “WEALTH!” [Many people may know that in Scandinavia, till this day, most of the people there call their “Land,” their “Rik.” That word is, simultaneously, the adjective, “rich,” as well as being the name for their “Land.” It is the same in the Netherlands. They call their Land their, “Rijk,” pronounced, “rike,” in Dutch. In Germany, the people

there have always called their Land their, “Reich,” pronounced, “rike,” in German, which is also both the adjective meaning, “rich,” as well as being the name for their “Land.”]

“So, what will be the result of the Colonists showing all of the other Translators, Computer Programmers, Businessmen etc., who follow the Colonists in setting up the Worldwide Interlingual Telecommunications Utility, how to run that Utility according to their Ancestral Heritage of the Essence of Ancient Germanic Europe’s Free Enterprise System?” As those people set up the Utility and run it that way they will be showing all of the Customers of that Utility, which are all of the People in the World, how to do the same thing.

“What will be the result of that?” The Entire World will be able to become a Germanic “RICH,” like London has always been and still is, “WHERE EVERYONE GETS TO KEEP ALL OF HIS/HER OWN WEALTH,” instead of having it robbed from them by some Romist Tricksters, as the Sad History of the Human Race, to this point, has, mostly, been a history of their doing.

“And, what will be the result of that?”

Well, for one thing, all of the “Wisdom” of what Romist Tricksters have been telling their Victims is the “Wisdom of the World’s Wise Men,” will be seen for all that it is in reality, just so many ancient ignorances and insanities that the entire Population of the Earth will now turn away from in a nauseated disgust, that will mean that “the Wisdom of the World’s Wise Men will,” now, at last, “PERISH!”

“And, nobody will even miss it?” Instead it would seem that the consensus will be, “Good Riddance!”

“And, is that the Purpose of this Synopsis?” No.

The Purpose of this Synopsis

As this Information has been presented, it has become obvious that Our Lord’s Beloved Human Family has a terrible “Achilles Heel,” the Consciences, that have made them into such easy Victims of the Devil and his servants.

It is one thing for the Information Age, through the Internet, to hold its Spotlight, through its Microscopes, on all of the disgusting Insanities that the Devil’s servants have pushed the Human Family’s noses into as being “the Wisdom of their Wise Men.”

It is another thing to have nearly everybody in the World today, because their Friends have gotten into this on the Internet etc., become nauseated at those Insanities, that are the Garbage that their noses and those of their Ancestors have been pushed into by the Devil and his servants for these Millenniums.

And, it is another thing for the entire Human Race to now, at last, as the Prophets have said would happen, turn away from that Garbage in the nauseated disgust that will let it perish – become “like the chaff of the summer threshingfloors; and the wind carried them away, that no place was found for them,” ever.

But, we need to see that just that, alone, cannot be the purpose for Latter-day Saints in making this Information available to the Human Family. When our beloved Prophet Joseph Smith, as a young man, inquired of his Heavenly Father, “Father, why did you pick me?” he was answered, “I did it because of your Family.” We have covered how the Lord referred to Joseph and his New Englander associates as, “You, with whom the priesthood hath continued through the lineage of your fathers. For ye are lawful heirs, according to the flesh, and have been hid from the world with Christ in God. Therefore your life and the priesthood have remained, and must needs remain through you and your lineage until the restoration of all things spoken by the mouths of all of the holy prophets since the world began.”

Also, as was mentioned, we know how Joseph was thankful when (after his wonderfully handsome oldest Brother, the most perfect looking person that anybody then living in America had ever seen, died, who died from Medical Malpractice, that had broken his Family’s heart), Heavenly Father revealed to Joseph that his oldest “Brother, Alvin Smith, was the handsomest man who ever lived, after Adam and Seth.” So, the two handsomest men who had ever lived were the First Two Patriarchs of the Human Family. And, it seemed that Heavenly Father was introducing to the Human Family who the current Patriarchs of the Human Family (the Oldest Righteous Son of the Oldest Righteous Son of Adam, traced in the Old Testament for 34 Generations, from Adam down to Joshua, the “Prince of the Tribe of Ephraim” and, therefore, the “Patriarch of the Human Race,” who was Moses’ Successor as the Leader of the Tribes of Israel) were, by making Alvin “the Handsomest Man Who Ever Lived, after Adam and Seth.” Alvin would have been the Second Patriarch of the Restoration, after his Father, Joseph Smith, Sr., had Alvin survived. And, as Heavenly Father told Joseph, “I picked you because of your Family,” so many of our Wonderful Leaders have come from that Family, as our Presidents, Patriarchs etc. They and our other Leaders set an excellent example for us as to how Latter-day Saints should conduct themselves in relation to all of the rest of the Human Family. Their excellent examples may be considered to be a part of the reason why it seems normal for Latter-day Saints to feel a little more of a devotion, than is common, to the rest of the Human Family, as we do our Genealogy Work for them etc.

But, a little more devotion, than is common, to the rest of the Human Family is not going to be enough to meet the challenges that are now beginning.

We Latter-day Saints have to be in love with our Human Family. We have to “give a hoot” for their Mental Anguish and do our duty, for all of our Brothers and Sisters of the Human Family, to not let them be destroyed by that Mental Anguish, as the Real History of the World, now becoming available, shows them how the Devil has destroyed the Souls of so many of our Brothers and Sisters through the Ages.

In the Doctrine and Covenants 76:103 our Heavenly Father talks of some of these Victims of the Devil's destroying of Souls: "These are they who are liars, and sorcerers, and adulterers, and whoremongers, and whosoever loves and makes a lie."

It is not the point that all of our Brothers and Sisters are going to turn away, in their nauseated disgust, from the lies which they see – which so many of them will see through this Invention from Utah of the Internet – that the Tricksters of the world have tricked them with, in order to rob them of their Money, destroying Souls in the process. It has been prophesied for Millenniums that something like this would happen, that will make "the wisdom of their Wise Men" "perish," and, then, be gone from them forever. But, that is not the point for us. Although some of us may play large roles in showing those Lies to the World, that is not the Supreme Duty that our Heavenly Father has imposed on His Latter-day Saints, in relation to all of their needing Brothers and Sisters out there in the World who are "WAITING FOR THEM."

"What are they waiting for?" They are waiting for us to save them from being more of the Devil's Victims, as their Consciences tell them how Evil they have been by being among those describable as, "whosoever loves and makes a lie," among all of the Lies that have, obviously, so completely dominated their Lives, until the Mormons, over their Internet, have shown them those Lies as just the Evil Garbage that they are.

Let's look at a couple of examples.

There was a song that was popular years ago Its words went, "Three coins in a fountain, through the ripples how they shine. Thrown by three hopeful lovers, somewhere in the heart of Rome. 'Which one will the fountain bless?'"

Apparently people, Merchants, "Tourists" etc., have been throwing coins, like that, in Rome for Millenniums, for luck, as they try to buy Romance there. "Why did the Romist Leaders say that the dead body that they had found was that of the Apostle Peter?" The Official Story is that it was because that body was found with a whole pile of coins piled up on top of it, coins that had been "lagged" onto it, like people lagging those coins to see that if they hit that body just right, on top of it, it would "bless" them with the Romance that they had come to Rome to buy. That is the Official Story.

So, they took that dead body and made it into the Kybernion of all of the "Governments" of Medieval Europe.

It can be scientifically proven today that that body is not the body of the Apostle Peter. It seems that it can be scientifically proven today that the Apostle Peter was never in Italy. Also, in his resurrected body he appeared to Joseph Smith and Oliver Cowdery.

However, as the Kybernion, sending out all of the Correct Hunches to all of Europe, and then the World, that cancelled the Sins of all who paid their Fines to the Cancellers of all of the Governments, that became the essence of all those Governments.

Think about some poor person thinking this.

This person might say, "What a 'Country' of absolute idiots that I live in. The essence of our 'Government,' in Washington DC, is our 'Capital Building.' Then, think of all of our Insane States, like our stupid State of Utah, where we think that we can't be a 'Government' unless we have a 'Capital Building,' that is also a brick for brick copy of the Washington DC Capital Building and of its 'DOME' so that those Correct Hunches can fly down the pole sticking out over its DOME so that they can, then, fly down into the heads of all of the Idiots who think that they can't have a 'Government' unless they follow this Insanity.

'How can I survive among such a pack of raving Idiots?'"

We may have large numbers of people despairing like this as the Information Age, on "Utah's Internet," begins letting everybody know what Governments used to forbid people from talking about.

Another of these Despairs could be, "Where is my Ancestral 'Government'? I want my Ancestral Government back!"

There is an easier answer for that. The people operating the Internet can let it be widely known that, "When Abraham Lincoln spoke of 'Government of the people, by the people, and for the people,' he was not talking about a bunch of Slaves on a Southern Tobacco Plantation debating about who was going to hoe which row of tobacco plants that morning. He was talking about New England and Midwestern, Northern, TOWNSHIP MEETINGS.

In this Age of the Internet we can have your Ancestral 'Plymouth, Massachusetts Town Meeting,' of the Internet, all day long, every day, in perpetual session. Everybody who wants to can vote on what they want as the By Laws of their Anglo-Saxon By, their Township, or for anything else that they want.

So, instead of your thinking that the Information Age is taking your Ancestral Anglo-Saxon 'Government' away from you and yours, you can probably have more of its benefits today than have been available before."

These are just a couple of examples of the widespread Despair that could swiftly spread today, among so many millions or billions of our Heavenly Father's Children, unless we do our Duty, as Latter-day Saints.

"What is that?" It is to be examples of that which they so desperately need." "Examples of what?" Examples to save their "Consciences." Their Consciences still whisper to them, somewhat, of what we all promised our Heavenly Father and Mother that we would do for them, as we all shouted for joy for the opportunity that they told us that they were giving us. Their Consciences so desperately need to see the Examples of SOME of their Brothers and Sisters who are KEEPING THAT PROMISE.

"What Promise?" LDS People know what Eternal Life is. It is to have the same Eternal Procreative Powers that Our Heavenly Parents have, to help them in the Work and Glory of God, to bring to pass the Immortality and Eternal Life of Man, and to procreate, as they do, Spirit Children.

The Consciences of all of the Human Family still sense, somewhat, how we all made that promise. “But, what do they see here, in contrast, done with Procreative Powers?” In the Romists’ “Renaissance,” when Romism was to be “re-born,” they got all of Renaissance England to believe that the Nordic Romans were all so noble that to do one tiny little thing naughty would kill them, as Shakespeare showed that he had been so duped into believing in his Play. “Whereas, what was the truth about such things, that Modern High-tech Detective Results are making known today to the Whole Human Race, over the Internet?” In reality the Dirty Little Romans stooped to being among the most contemptible, mass-scale “Whoremongers” that Mankind has ever heard of, in order to trick the World out of their Concept of “Money,” that they had developed.

“Are the Latter-day Saints good examples in this area?” They are so good that their Heavenly Father used them to show the whole World how to keep that “Original Promise” to our Heavenly Parents as puristically as his Ancient Prophets and Patriarchs, Abraham, Isaac, Jacob, Moses etc. did. Of course the World has been taught, in the past, that all that the Mormon Pioneers were doing in their Territorial Utah Intermountain West was putting together a bunch of Modern-day Mohammedan Harems. However, today is the Information Age, of the LDS Internet. The World will learn the Truth and see how Our Heavenly Parents rewarded their Faithful Children, so many of the Mormon Pioneers, who kept that Original Promise, in these Latter Days, at the same high level that the famous ancient Prophets and Patriarchs did. One way in which He rewarded them was to bless them with a “Most Glorious Progeny,” for example, in the same way in which those famous Ancient Parents were rewarded for keeping that Original Promise.

Our Heavenly Parents want their Human Family to be run by Revelation from them. Revelation that comes from them shows each Man and Woman how to Love the Lord, their God, with all of their Minds as they go through that Strait Gate and proceed ahead along that Narrow Way, led by the Holy Ghost, to make part of Our Heavenly Parents’ Family in this World, that is that Man and Woman’s preparation – by keeping their ORIGINAL PROMISE – to be able to do the same in the Next World.
