**It seems that the main problem is that they have been going to the Organization that had the biggest effect on stopping Our People from being able to learn how to “Work Together By The Law,” to study from them on how they would tell us how to “Work Together By The Law.”**

**That doesn’t work. This following Paper gives reasons why that doesn’t work.**

# **The Southern Slaveholders' Declaration of Dependence on the Bank of England**

We hold these Negro Slaves in Absolute Slavery. We can take the Life of any one of them any time that we want to. We allow them absolutely no Liberty, whatsoever. It seems that they are Happy every once in a while, if we hold off from whipping them; but we can whip anyone of them to death at any time that we want to.

We keep them in this Slavery for our Masters, those who own and run the Bank of England, for whom we work and who provided us with these Slaves in the first place. These persons built up the very profitable Worldwide Tobacco Business by addicting numbers of people, in Europe and elsewhere, to uses of this Deadly Narcotic Plant that was discovered here in the Americas. They figured out that the most profitable way to produce it was the way that they got Caribbean Spaniards to do that, by having the work done by Black African Slaves, each of which individuals they call, a "Black," in Spanish, the Spanish word, "Negro."

When the Followers of "the Law" of the Ancient Anglo Saxons, who founded England, decided, in the mid-1600's, that their Ancient Anglo Saxon Free Enterprise System, which is the way that their "Law" operates socially, was being attacked too much by the Romistic Feudalism, that our Norman French etc. Feudalistic Forefathers had introduced into Britain, that it was taking over too much of the control of things in England, we "pushers" of Feudalism had to flee from those Followers of the Law. The part of English America that had been controlled by Feudalism was "the South," so we came here. The Pushers of Feudalism in Europe, who had begun the Narcotic Tobacco Business, told us that they would set us up with Negro Slaves and in the business of the growing and harvesting of Tobacco in this Area, because Tobacco will grow here in the Southern Climate as it has on the Caribbean Islands.

We do everything that those Controllors of the Bank of England and of the World Tobacco Business tell us to. It is not as though we are unable to think. It is the fact that every farthing that we get, that buys our food, clothing and shelter, comes from them. So, everything that we do, say, promote etc., as a Group, is what they tell us to. What any one of us might individually or personally think never comes up, because that is not the point. What our Business Masters, who own the Bank of England and the World Tobacco Business, by whom we are employed and for whom all of our Work Product is produced, tell us to do, say, promote etc., is what we do, say, promote etc.

"So, what is it that they tell us to do, say, promote etc.?" They tell us to work for their "Goal." "And, what is that?" They have explained to us something of the fact that they are the traditional Archenemies of the White, Christian Race of Northern Europe. They are those who organized Attila the Hun's Attack on Northern Europe, that drove the Anglo Saxons to Britain in the first place. After that failed they organized

Mohammedanism as the entity to oppose and attack them. When the North Europeans responded to that with their Victorious Crusades, that were subduing Mohammedanism as an attacker against them, these Archenemies organized Genghis Khan to try to do to Northern Europe what Attila the Hun had failed to do. However, just as the traditionally, “Second Most Important Invention in Military History,” the Invention of the Stirrups Saddle by North Europeans, that was the Invention that let them begin their “Knighthood,” with which they destroyed Attila the Hun, so the “Most Important Invention in Military History,” Guns, was invented by the North Europeans’ Organization for Working Together By Their Law, their Guild System, to shoot off from their horses all of Genghis Khan’s Attack Force of 700,000 Mounted Lancers (the biggest Force of Mounted Lancers in History) that were unlucky enough to come into the range of their Guns.

With that Military Failure Europe’s Archenemies knew that they wouldn’t be able to defeat Northern Europe militarily. So, they performed the “Two Biggest Human Caused Slaughters in History” recorded in “Guinness’ Book of Records.” The Second Biggest of these was to take those of the 700,000 Mounted Lancers who hadn’t been shot off of their horses back to the Land that had been the principal source of supply for that Force of Mounted Lancers, China, where they had that Force murder virtually every man in China in the process of their robbing China of almost all of its theretofore Great Treasures of Gold. That Gold was then transported to the western-most part of Europe that Genghis Khan’s Forces had conquered: Poland, Lithuania, Byelorussia and the Ukraine, to there begin, with that Gold from Butchered China, those Archenemies of Europe’s concept of their “ANTI-GUILD-SYSTEM,” “BANKS.” Their Concept was to trick the North European People into thinking that they were still Working Together By Their Law, the Law of the Guild System of their Forefathers, as they began Working Together for the Romist Concept of Gold Coin Money in this Anti-Guild System being foisted on them by their Archenemies as this novelty of a new “GUILD of BANKERS.” That is, they were tricked into allowing into their most honest Ancestral System, for Working Together By Their Ancestral Law, their “Free Enterprise System,” their “Guild System,” wherein every Free Man gets to vote his WEALTH – literally his “Voting Power” over that which he has honestly earned – the Romist Concept of Gold Coin Money, historically issued by the most dishonest, un-Christian-principled people in History, murderous, thieving Military Dictators.

Of course there was no way that West Europe – giving thanks to their God for their Guild System’s Invention of Guns, that seemed to be the Triumph of the conclusion of the Crusades, that had delivered them from the likes of the horrors of Genghis Khan’s Gigantic Force of Mounted Lancers – would stoop to such a nauseating lowness, with that Gold that had recently been so abominably stolen from the Millions of Murdered Men of Butchered China, who were its immediately previous possessors. So, Christian Europe’s Archenemies felt that West Europe needed to be humbled to that acceptance. Their Plot was to impose upon Christian Europe “The Biggest Human Caused Slaughter in History” that is recorded in “Guinness’ Book of Records.” In a remote portion of Central Asia there is an endemic, horrifying Rat-Flea Symbiosis that causes the Black Death. Boxes of these Diseased Flea carrying Rats were in great secrecy transported over

thousands of miles by these Archenemies of Christian Europe to locations where they would be unnoticed as they were placed into the cargo holds of West European Sea-going Vessels. As those Ships returned to their Home Ports in Western Europe the Disease-carrying Rats escaped off of those Ships so that the Black Death quickly spread very widely across Christian Europe, inflicting upon it “The Biggest Human Caused Slaughter in History.” That Plague, perhaps the worst that ever happened, killed off so much of the Manhood of Western Europe, especially of the “Learned in relation to Commerce” Seafaring Manhood of Western Europe, that their Archenemies were able to begin their ANTI-GUILD of BANKS among the humbled, struggling-to-survive, less commercially learned Survivors left in Western Europe.

As soon as Western Europe’s Archenemies were able to get their ANTI-GUILD of BANKS established among the Black Death decimated Survivors of Western Europe, they immediately began their ALL-OUT MENTAL WARFARE, against all West Europeans, to prevent them from continuing to Work Together By The Law of their Forefathers, through their Forefathers’ Guild System. Their Goal was to make it so that the only way that they could survive was by working together for the, originally, Southeast European, “Romist,” concept of Gold Coin Money, that was, really, only available to them through their Archenemies’ ANTI-GUILD of BANKS.

As those Archenemies so rigorously pursued that and such horrible destructions as “The Thirty Years War” broke out among West European Christians because of that, the “Overall Organization” of the Guild System of West Europeans began to dwindle. That “Overall Organization” of the Guild System of West Europeans, that was known by the name, “the Hansa,” of the language of the Archenemies of the Romists, the Goths, which Overall Organization was led for so many centuries from its headquarters on an island of Gothland, seemed to be mortally wounded. As the Hansa dwindled in the Lands of Europe its concept of a people, who spoke a specific Language, of Working Together By The Law – which, in one sense, meant working together by the Wealth of all of the Members of all of Northern Europe’s Guilds – was gradually replaced by a Concept of the traditional Archenemies of Northern Europeans. That replacing Concept was that, for a people speaking a specific Language, instead of them working together by their Ancestral Concept of Wealth, that was changed for them. That change was for them to start working together by the Rules of a “CENTRAL BANK,” that supervised the way that a people who spoke a particular Language would, in the future, work together.

As the Thirty Years War concluded the principal headquarters of the Historic Hansa that could not be successfully attacked, by Invasions etc., was the Hansa Headquarters of the Ancient Commonwealth of London, built and operated through so many centuries by the Archenemies of the Romists, their Conquerors, the Visigoths. However, the Commonwealth of London was so revolted by the insidious attacks upon it by the Romist Feudalists who had “enslaved” the countryside Peasantry of England, to be their servants, that London chased great numbers of such Romist Feudalists out of England, did away with those Romist Feudalists’ Monarchy, and began to try to let all of England work together, again, as a Commonwealth.

That is the expulsion from England, that drove so many of its Feudalists out of England, to look to continue their feudalistic way of life as the Slaveholders of the Negro Slaves that were brought from the Caribbean Islands to the Feudalistic Environment of the Southern British Colonies. In order for these Feudalists to survive there, as the ones “driving” the Negro Slaves to produce the Narcotic Tobacco Products that the Organization that was establishing Western Europe’s Central Banks were using to addict the Population of Western Europe to the debilitating results of their addiction to this Narcotic, those Feudalistic “refugees” had to do exactly what they were told to do.

It is easy for the man on the street to see, today, why the traditional Archenemies of White, Christian Europe became so intent on taking over London and setting up the Bank of England there at that time when the Commonwealth of London drove the Feudalists out of England, temporarily brought all of England into its Commonwealth etc.. If an attempt was made today, to take all of the substance that is used to make Gold Coin Money, that is all of the Gold in the World, that has ever been mined, and use it as Money today, with the size of the World’s Population today etc., that type of Money would only suffice to pay the Bills of all of the People in the World for about one or two days. The amount of that Substance makes it completely insufficient today to serve the purpose for which it was used anciently. “What does serve as the Value that the Bank of England operates all of the Central Banks of the World with today, which is the control of all of the Finances of the World today?” The “WEALTH” of the Free Men of London.

Today the, approximately, “500,000 London Free Men” who constitute the current Commonwealth of London, control Quadrillions of Dollars worth of the Anglo Saxon concepts and words of “Stocks and Bonds,” that they and their Commonwealth have earned by “Working Together By Their Law” for well over the Millennium and a half that they have been doing that there. It is that WEALTH that serves as the Value through which the Bank of England controls the “Fiat Money” operations of all of the World’s current Central Banks.

The Free Men of London have thought that they know how to “Work Together By Their Law.” That is, briefly, working together in the Environment of the Absolute “Honesty” that each one of them takes his Oath, to do his work by, in London’s Christian Temple, which Oath is what it is that lets each one of those men become a London Free Man, in the first place. The WEALTH, in the Ancient Anglo Saxon “Stocks and Bonds” that each one of them have earned over the past Millennium and a half, of their doing that there, is the WEALTH that the People of the World “work together” by today. All of the People of the World, today, would love to just be able to work together by the Law of the Free Men of London without that horrid “Top Layer” over it that allows so much of the Criminality and Abuse of the “Money” of Medieval “Governments” to influence their Lives so negatively, as is done by that Organization of the traditional Archenemies of White, Christian Europe that took over London at the time of which we speak. So, that now brings up the question, “How was it that they were able to take over London?”

The quick answer is that they knew that the Free Men of London did NOT know how to Work Together By Their Law; but, again, “What was the Situation?” These

Archenemies got the Gold that they needed to take over the Money Culture of Europe by, as was mentioned, murdering so many millions of the Manhood of China that they were able to commit one of the very Largest Grand Larcenies ever. Then, to weaken the Guild System of Europe, after its Triumph against the Last Attempt of their Archenemies, who were the Other Side of the Crusades, in order for those Archenemies to be able to get their ANTI GUILD SYSTEM of BANKS, operating on the Money it made from the Gold that they stole from Butchered China, they transported the Black Death Symbiosis to Western Europe to produce the Biggest Human Caused Slaughter in History. Then, as their Archenemy, the Hansa, that had supervised the Operations of North Europe's Guild System, began to weaken, they were in a position to replace its Supervision over the way that the people speaking a specific Language in Europe worked together through their Ancestral Guild System, with their Concept of them working together, from then on, under the Supervision of one of their CENTRAL BANKS.

But then the question arose among all of them as to what they needed to do in order to be able to create their CENTRAL BANK of all CENTRAL BANKS. London had been such a powerful headquarters of the Hansa, for westernmost Europe. The Free Men of London really felt that they knew how to Work Together By The Law of their Forefathers, which was the dynamic base that these Archenemies needed to form their CENTRAL BANK of all of their CENTRAL BANKS, all over the World. However, these Archenemies knew that the Free Men of London did NOT really know how to Work Together By Their Law. When they got their absolute proof of that that is when they made their Move. "And, what was that?"

When London made all of England back into a "Commonwealth," again, it was like it was being made into something like "a USA of England." The "president" of the Commonwealth showed that it really did NOT know how to operate like the Original Anglo Saxon Commonwealth, that it had started out to be, over 1,000 years before, when that President decided that he needed to borrow some of the Romist innovation, to the original Anglo Saxon Law, of Romist Gold Coin Money from Christian Europe's Archenemies. They said that they would make that Loan if some of them could move into England. He let them do that. No Monarch of England could have done that because it was against his Coronation Oath to let those Archenemies in. However, there were no more Monarchs of England during the Commonwealth. As soon as those Archenemies were allowed in they, apparently, figured out that that President could just as easily make them get out, again, so, apparently, he was murdered by those Archenemies about a year after he first let them in.

So, now London was "open" to them, to set up their CENTRAL BANK of all CENTRAL BANKS there. The answer to the question, "How to get in?" was a fairly simple one to answer. "How had they gotten their CENTRAL BANKS into any of Christian Europe in the first place?" They decimated Christian Europe with the Black Death Rat-Flea Symbiosis Plague that they had transported there from Central Asia. All that they needed to do was to just spread another Plague, but this time only within London. The result of their "Great Plague of London" that they brought there did get rid of enough of the adherents to the former Law that a way was open to them. "But, then,

how could they live in that Great Plague of London-infested location. That answer was also quite simple. All that was needed was for them to just start “the Great Fire of London” and let London be burned down to the ground. That was their obvious answer to get rid of all of those deadly Plague-producing disease spreaders: “Burn them up!” Then, when the Leading Guild of London rebuilt its Lodge Hall on the ashes of burned-up London their next move was made to make that into the Headquarters of their Bank of England, their CENTRAL BANK of all CENTRAL BANKS, for them, from there, to be able to control, essentially, all of the Finances of all of the World.

“Okay, but then how did it get from there to ‘The Southern Slaveholders Declaration of Dependence on the Bank of England’?” The Bank of England has felt that it has a horrible Achilles Heel, from its very beginning. During the Thirty Years War, from 1618 to 1648, while so much of the rest of Christian Europe had been tricked into fighting each other, by their common Archenemies, the way was open to the London Fishing Navy, of the Second Most Influential Guild of London’s Guilds, to transport about 20,000 of their numbers across the Atlantic to take advantage of the Grand Banks Fishery, one of the best Fishing Grounds in the World, which was, essentially, the Coastline of the Northern English Colonies, in large part the Coastline of New England.

Like their London Forefathers and their other London Kinsmen, these 20,000 Settlers of New England felt that they KNEW exactly how to Work Together By Their Ancestral Law of London. And, reflecting their commitment to apply that Honesty, that is the essence of London’s Law, to their presence on the North American Continent, they did something that would be expected from the absolute commitment to Honesty of the London Guild System.

As all may know, when Columbus discovered America he thought that he had arrived in India, so he and his Spaniards named the inhabitants that they found here, “the Indians.” Because Columbus’ purpose in trying to reach India was to stop the services of the people of India to the Archenemies of Christian Europe, who were the Other Side in the Crusades, had supplied Genghis Khan etc., he and the other Spaniards treated the “Indians” of America as the enemies of Christianity and deprived them of many things before Magellan proved that there was a Pacific Ocean between America and India and that these American Natives were innocent of the evils that had been guessed about them. That changed things somewhat; but first impressions are lasting; and Spaniards, in general, retained a disposition of despoiling the American Natives. Many feel that the Feudalistic Southerners adopted that same attitude toward the Natives of the British Southern Colonies. Many, including so many of their Native victims, felt that those Feudalistic Southerners and their Tobacco Industry were unapologetically in the Americas to murder the Native Family that had lived here and to steal their home from them.

However anything like that might have applied to other Europeans in the Americas, nothing of that nature related to the Settlement of the New Englanders in New England. They knew that they had absolutely no right whatsoever, in God’s eyes nor those of decent men, to be on the Land of this Innocent People unless they were invited to be here by those Natives because of their having EARNED that right to be here.



In their very most solemn “Title” that they used to be here upon this Land, they said that their “ONLY END” in being here was to “win and invite” the American “Natives” from their very low poverty to enjoy with them the Highest Standard of Living in the World, of the “Wealthy” London Free Men of the Commonwealth of London. They named their colonies, “Commonwealths” [It is bad taste in Massachusetts, till this day, to call it, “the State of Massachusetts” rather than, “the Commonwealth of Massachusetts.] and invited all Native Americans to listen to their “Orderly Conversation” that explained to those Natives how they too can “Work Together By The Law,” with their Fellow New Englanders and become “American Free Men” [in the same way that in London they who are there become “London Free Men”], and rise from their lowest poverty to begin enjoying the Highest Standard of Living in the World with their fellow “American Free Men” of New England.

Now, if the People of the USA ever did learn how to Work Together By Their Law, instead of by the Romist Money produced by their Archenemies, they would be able to free all of the World from the Slavery that they are held in by the Archenemies of Christianity who control the Finances of all of the World through their control of all of the World’s CENTRAL BANKS, which they, exclusively, own and operate.

That has been the Nightmare of the Archenemies of Christianity, who run all of the World’s CENTRAL BANKS, that the silly New Englanders and their American Descendants would ever be able to Work Together By The Law of their Anglo Saxon Forefathers, teach that to a World waiting to hear it, and throw the Archenemies of Christianity from their current high position of rule into some unknown garbage can.

However, they knew that that was not going to happen at the time of the American Revolution nor shortly thereafter. The “Orderly Conversation” that the Colonial New Englanders had as to where the Law of their Forefathers came from and how to Work Together By It, was such a childish sunday school line, taught to them by their Medieval Romist, Feudalist enemies, that it was very easy for the Archenemies of Christianity to recruit some Southern Slaveholders who were able to most easily throw that “Line” of reasoning into its garbage can. That is where it has stayed till today.

Again, the Nightmare of the Archenemies of Christianity, who currently rule the World through the Financial Institutions of London, is that the American People will ever learn how to Work Together By Their Law and teach that on to the rest of the World that is waiting to learn that. Those Archenemies’ GOAL is that they never learn that. To achieve that Goal after the American Revolution, to stop the former “Colonial” New Englanders from going out to settle their richest westward extensions of New England in their Midwest (the rich lands where today are located such World-leading centers as Cleveland, Detroit and Chicago) the Archenemies of Christianity recruited the Feudalistic Southern Slaveholders to “throw their Line of Reasoning into the Garbage. Since then they have been recruiting the imitators of those Feudalistic Southern Slaveholders to demonstrate to the American People that they do not know anything but Nonsense in relation to how to Work Together By Their Law.
