

“What ‘Lawful’ ‘Title’ Do You Have To Live On The North American Continent?”

A more encompassing aspect of that Question might be asked as, “What ‘Lawful Title,’ that the Whole World accepts as ‘Lawful,’ do the English-speaking People, in general, have to Live on the North American Continent?”

From the inattention given to subjects of this nature, in conventional Schooling, one could ponder, “Could the intention to come to this Land to Murder the Family that used to live here and to Steal their Homeland away from them, create a ‘Title’ to this ‘Land’ that the Whole World would accept as ‘Lawful’?” And, of course, even though such a probable thought for consideration might come up in the minds of many, even though it is scarcely ever mentioned, the answer to this encompassing Question would, of course, be, “No, the intention to come to this Land to Murder the Family that used to live here and to Steal their Home away from them would not create the ‘Lawful Title’ for those perpetrators to live here, in the minds of everyone across ‘the Whole World’!”

Such broad questions, of this nature, might bring up other broad questions. One such question might well be, “Is there anything in ‘the Whole World’ that ‘the Whole World’ does, in fact, consider to be ‘Lawful’?”

The answer to that question has a very exact positive answer today. It is that today the “Business Law” that “the Whole World” has now adopted and operates on is considered to be “Lawful” by “the Whole World.”

“And, where does this ‘Business Law’ come from, that the Whole World operates on today and considers to be ‘Lawful’?”

It is popularly called, “The Free Enterprise System,” by people all around the World today. However, to answer, specifically, “where does it come from,” it is the Ancestral “Guild” System of the “Nordic Race,” of Northern Europe, which all of their Records show to have been the “Business Law” of all of that part of the World since the First Century of the Christian Era.

A relevant question might be, “How did it survive down through the Ages so that today it has become the Business Law of the Whole World?” However, that brings up another subject that is not addressed in Conventional Schooling, that of the subject of the Impartial, “non-propagandized,” Scientific Treatment of “Military History.” The Navy of the Christian Side of the Crusades has dominated World Trade since its Victory in the First Crusade. “The Free Enterprise System,” “The Guild System,” The Business Law of that Navy has grown with that dominance and has gradually been accepted by all of the Peoples of the World until today it has become the Business Law of the Whole World.

Owing to the Viking Origin of that Navy, the “League” of virtually all of the Fortified Harbors across all of Northern Europe (the Home Ports of that Navy) from the time of the Crusades, bore the Viking name, “the Hansa.” However, since this League nearly uniformly became Protestant at the Reformation, Catholic Countries of central and southern Europe attacked it during the Thirty Years War, 1618 – 1648, which virtually destroyed that League and the North European Guild System along with it as well.

The one Fortified Harbor that the Armies of the Catholic Countries could not effectively attack, because of its location on an island, the Island of Britain, was the Hanseatic Fortified Harbor of London. It, apparently, operates today exactly as it did in the year 450 AD, when the Anglo-Saxon People replaced the Occupation by the Roman Empire’s Infantry of that portion of the Island of Britain that it had occupied. From the London Guildhall, its City Hall, the 500,000 London Free Men, the Members of its 25 Ancient Guilds, operate the London Bond Market, which is the Financial Capital of the World, which controls all of the Central Banks of the World, which establish the Business Law of the World which all of the Finances of the World operate on today.

The entire World today, which all accepts the Finances that originate from London, operates on its Business Law. “And, what exactly is it?”

The “Premier” Guild of the London Guild System, through the Ages, has been The Merchants Guild. The members of this Guild in London, as in all of the other Harbor Commonwealths that composed the Hansa, are those who regulated the exchange of the production of all of the other Guilds. The “Law” of the Merchants Guild is known as, “the Law Merchant.” The Law Merchant is the “system” that the World thinks of in its popular modern expression, “The Free Enterprise System.” The Law Merchant has today become the Business Law of the Entire World.

“And, what, exactly might the Law Merchant be?” There was only one text written about the Law Merchant during the entire Twentieth Century. Its title was, “The Romance of the Law Merchant.” Therein it is stated, “The basis of the Law Merchant is the presumption that the Merchant does all that he does IN GOOD FAITH.” In the USA, today, now removed by centuries from the former integrated contact that its People had with the operations of that Commonwealth of London, the expression, “good faith,” generally only means that someone is not lying. It has never meant nothing more than only that in London. Article 13 of the Magna Carta states: “The City of London shall have its ancient liberties and free customs, by land and by sea.” By these Ancient Liberties and Free Customs of the Ancient City of London, the concept of doing “all that” one “does in Good Faith” has always meant that one does all that one does in the Good Faith of the Lord Jesus Christ.

And, as one comes to consider this subject for the first time, it might be expected that the question might arise, “I wonder how it is that these ‘Ancient Liberties and Free Customs’ of ‘the City of London’ (first) have survived intact through all of these centuries and (second) have presented themselves to the Whole World today in such a way that the Whole World today, so eagerly, accepts them?”

A short answer to that question might be that as the various Peoples of the World have come into contact with these “Principles,” which they see in operation in these “Ancient Liberties and Free Customs,” of this Business Law that has always been the essence of the Free Enterprise System, they have, individually, felt that, “The people who have operated according to these Principles, from their recorded beginning, whom I find bringing to me the benefits of the ‘Business Success’ that they seem to have always been enjoying, are the Principles that I also want to begin operating according to in order that I might also begin participating in the enjoyment of the benefits of this ‘Business Success’ that I see them introducing to us.”

And, now, back to that question posed at the beginning: “What Lawful Title, that the Whole World accepts as Lawful, do the English-speaking People have to live on the North American Continent?”

The Lawful Title that the English-speaking People, who began the US North, brought to their “New” England was the same Title that their Anglo-Saxon Forebears brought with them to the Island of Britain as those Forebears began living there after their Cavalry had expelled the Roman Infantry from its rather shallow occupation of the southern part of that Island. [Unlike in France, where the people there adopted the Latin Language that the occupying Roman Infantry had brought with them from Italy, the Roman occupation of England was shallow to the point that their Language was not utilized by the population in an ongoing way.] In contrast, all of those peoples who had been the occupants of the Island of Britain before the Romans came did accept the Language and the Law of the Anglo-Saxon Cavalry, that removed that Roman Infantry from its former, temporary occupation of the southern part of the Island of Britain.

Although perhaps the premier fact in the Military History of Europe, the fact that the Cavalry that harried the Infantry of the former Roman Empire out of its temporary occupation of all of Western Europe, and introduced there the “age” of Knighthood [which was, about, the subsequent 1,000 years], was composed of Christians, is only acknowledged in very obscure references, rather than being highlighted in the area of being one of the premier facts of the Military History of Europe. When a segment of that Christian Cavalry, then, proceeded to also harry that portion of the Roman Infantry that had occupied southern Britain off of that Island, it established the Commonwealth of London, that, officially, operates on the same Ancient Liberties and Free Customs today that it did in that ancient year of 450 AD. The Anglo-Saxon people, who followed that Cavalry, were fleeing to Britain to escape the onslaught out of Asia by the Hun leader Attila, who had been paid tons of Roman gold coins, by one of the last Roman Emperors of Western Europe, to destroy, through a surprise attack, the Christian Cavalry that was harrying the Romans’ Infantry out of Western Europe. These Anglos-Saxon refugees brought the Successful Principles of the Business Law of their new Commonwealth of London to the peoples who had lived on the Island of Britain before the Romans’ Infantry had come there to occupy a portion of it. By the acceptance by these earlier British peoples, of these Successful Business Principles that were offered to them by the arriving Anglo-Saxons, along with all of their Business Law and their English Language that it was expressed in, these earlier British peoples exhibited an outlook of acceptance which

they had not had for those affiliated with the Roman Infantry's occupation of their part of the Island of Britain.

Now let us address the matter of how the Lawful Title that the English-speaking People brought with them to live in the portion of the North American Continent that they called, "New England" (from the 40th to the 48th Parallels – from about the Mason-Dixon Line to Canada – from coast to coast), was the same Title that their ancient Anglo-Saxon Forebears had offered to those earlier inhabitants of Britain who had accepted it there to create "England."

The "American Republican Form of Government" began with the founding of the Colony of Connecticut. Its Founder "invented" the "American Republican Form of Government" when he invented the idea of basing it upon his concept of a "Written Constitution." (The Constitution of the Colony of Connecticut, which is called, "the Constitution State," was the World's First "Written Constitution.") When that Founder of Connecticut talked the rest of New England into following Connecticut's precedent and basing the Title of all of them to be here upon the North American Continent by Connecticut's approach to its Title to be here, he did so by coining the phrase to express this Approach as, "The Consent of the Governed," which thereupon became the "Slogan" of all of New England up until the Revolution and of all of the rest of the United States of America thereafter. (Following the example of the USA's following of Connecticut's precedent, as of about fifteen years ago, every National Government in the World but seven had followed that precedent that had been set by that Founder of Connecticut.)

The English Civil War, of the mid 1600's, began in England as the Thirty Years War was concluding on the Continent of Europe. After the English Civil War, the Government of England had to justify, for what was left of the Hanseatic Navy, the ownership by Englishmen of the World's Choicest Fishing Grounds, the Grand Banks Fishery on the Continental Shelf of the North American Continent, which extends between the 40th and the 48th Parallels, which, of course, was the reason for the establishment of New England in the first place by the London Fishing Navy, which establishment was established by London's Second Guild in Precedence (after the Merchants or "Mercers" Guild), which is the London Fishmongers Guild. This London Fishing Navy, of the London Fishmongers Guild (in large measure because of its control of those New England Fishing Grounds), rapidly grew during the 1700's to become the dominant Navy controlling all Trade on all of the Oceans of the World until the mid 1900's, when it was replaced in that capacity by the Navy of the USA.

When the New England Company was begun in England, in 1620, shortly after the Thirty Years War began, in 1618, it must have seemed a most pleasant prospect to the other Hanseatic Commonwealths that their Hanseatic Commonwealth of London – which was virtually unreachable by the Roman Catholic Armies that were attacking and destroying so many of the Fortified Harbors that were the Hanseatic Commonwealths on the Continent of Europe – was committing to the rest of the Hanseatic League, in the most solemn and sacred terms that they all shared, that they were going to firmly establish throughout the North American Continent, which was also so well out of reach

of all of those Roman Catholic Armies, that ancient treasure that was the essence of their Ancient Hansa (now, so soon to slip out of existence on the Continent of Europe), their Ancient Hansa's ancient "Free Enterprise System."

The Ancient Hansa's Navy was still, by far, the most powerful Navy in the World, until well into the 1700's. It could have easily completely demolished the fledgling little Commonwealths that the New England Company was establishing along the Coastline of the Grand Banks Fishery, which were then only inaugurating the much later tremendous growth of the British Navy, which the, then, little London Fishing Navy was at that time just commencing its subsequent growth of there. The Government of England took great pains to show that, then, Most Powerful Navy in the World how this soon-to-be rapidly growing London Fishing Navy, that was being built in New England, was nothing other than their "Dream Come True," of a most glorious future for the Hansa's Free Enterprise System, rather than "any problem at all" that the Hansa's Navy had to be concerned with in detracting in any way from the Free Enterprise System's most promising Future on the North American Continent, that was then standing out in such a stark contrast to the apparent imminent end of the Free Enterprise System's being able to continue to function as it had for so many centuries across Northern Europe.

"How was the Government of England to communicate to London's fellow Hanseatic Commonwealths, of so many centuries, 'in the most solemn and sacred terms that they all shared,' how the London Fishing Navy was going to establish, throughout the North American Continent, the Hansa's ancient Free Enterprise System, in the most vital, promising – read 'Most Promising to become a Business Success' – way that the, then, controllers of the Hansa's Navy could have hoped to have had that communicated to them?" It was through the Royal "Charter of the Colony of Connecticut" of 1662.

Therein the Government of England assured the then waning yet still most powerful Navy in the World of the "only" purpose of Connecticut and of the other New England Colonies that were following its organizational lead. That only purpose, Connecticut's "only end," is expressed therein as follows: (utilizing the original spelling) "as their good life and orderly Conversacon (conversation) may wynn (win) and invite the Natives of the Country to the knowledge and obedience of the onely (only) true God and Saviour of mankind, and the Christian faith, which in our Royall (royal) intencons (intentions) and the Adventurers free profession is the onely (only) and principall (principal) end of this Plantacon (plantation)."

Therewith, "in the most solemn and sacred terms that they all shared," the Government of England assured the Surviving Rulers of the Hansa's Navy that the "only end," the only reason, for the New England Settlers to ever be on the North American Continent was always to be so "as their good life and orderly conversation may win and invite the Natives of the Country to the knowledge and obedience of the only true God and Savior of mankind, and the Christian faith, which in our Royal intentions and the Adventurers' free profession is the only and principal end of this Plantation."

Therewith the Government of England assured those Surviving Rulers that the basis of the English-speaking People's being on the North American Continent would forever be what has always been the basis of the operation of all of the Principles of the Business Success of that Foremost Treasure of the Nordic Race, the Law Merchant, that is their ancient Free Enterprise System, that, in the words of the Connecticut Charter – are to be THE ONLY END FOR ALL OF THE ENGLISH-SPEAKING PEOPLE TO EVER BE ON THE NORTH AMERICAN CONTINENT, WHICH IS THAT IT SHALL ALWAYS BE SO, “AS THEIR GOOD LIFE AND ORDERLY CONVERSATION MAY WIN AND INVITE THE NATIVES OF THE COUNTRY TO THE KNOWLEDGE AND OBEDIENCE OF THE ONLY TRUE GOD AND SAVIOR OF MANKIND, AND THE CHRISTIAN FAITH,” – or in the Traditional Wording of their Ancient, Common, Law Merchant, are that THE ONLY END FOR ALL OF THE ENGLISH-SPEAKING PEOPLE TO EVER BE ON THE NORTH AMERICAN CONTINENT IS THAT “ALL” THAT THEY WILL EVER “DO” HERE WILL BE “DONE IN” THE “GOOD FAITH” OF THEIR LORD AND SAVIOR JESUS CHRIST, THE “CHRISTIAN FAITH” THAT HE DELIVERED TO THEIR FOREFATHERS.

That is the original Title of the English-speaking People to live on the North American Continent. There is a detailed Booklet available that gives many of the particulars of the lengths to which the New England People went to share this Ancestral Treasure of theirs, that we have spoken of, with “the Natives of the Country,” with whom they intended to share their Ancestral Treasure in an “Exchange” with those Natives for allowing them to live here with them according to that Ancestral Treasure's Pattern. One of the arrangements that was a part of that Pattern, that all instantly recognize, was the division of the North American Continent up into New England “Townships,” each one of which was to have a public, free Elementary School which, by that Arrangement, all English-speaking children are compelled to attend. All of the children of the Native American People were to be so cordially invited to also attend that they would want to. This cordial invitation included that all School Employees and the School Children would have to be so much on their very best behavior that it would be easy for the Natives to see the “Good Life” of this Heritage and feel that they wanted to learn the “Orderly Conversation” of these English-speaking People that would show these Natives, as well, the road to the enjoyment of the benefits of the Business Success that can come to one by participating in this Free Enterprise System Ancestral Treasure of these English Speakers.

That participation was then to allow them to subsequently attend the New England Prep School (High School), to be established in every County into which all of these New England Townships were to be organized. And, then, if that participation there was successful, these successful Students, English Speakers and Native Americans, would find the road open to them to attend an institution like that first one that was established in the Massachusetts Parish that was founded by the Parish Members of the Minister who later founded Connecticut (that Founder of Connecticut was a Church Minister), which Massachusetts Parish was that of Cambridge, Massachusetts and which institution was Harvard College, later Harvard University.

Some “outsider” observers, whose People decided to join in to begin to enjoy the benefits of the successes of the Free Enterprise System at some time in its history, might be impressed to observe, “The American Indians got a good deal out of this ‘Exchange’ that the New Englanders set up for them, of their Ancestral Free Enterprise System in exchange for the permission for it to operate on the Indians’ Land.” It might be somewhat “propagandistic” if they continue on with, “After all, they used to be just bands of wandering Savages, always at war with and killing each other, while now they have available to them the highest, most sophisticated Culture in the World, the same Culture had by the 500,000 London Free Men who operate their Multi Quadrillion Dollar London Bond Market that operates the Economy of the Whole World today.” However, probably most of the people in the World today would feel some degree of agreement with the idea, “You know, I hear that most of them used to live at the level of the most dismal poverty, constantly facing starvation, always facing the prospect of freezing to death in their rags for clothing or nakedness, with no idea for how to built appropriate housing for themselves, always facing the prospect of dying with no almost no hope at all of care for all of the diseases that came along etc. etc., while today they have the Highest Standard of Living in the World easily available to them by merely availing themselves of it.”

However, of course, the “Issue” in the original Title that the American People proposed (to the People of the World) to be THE Title allowing them to be on the North American Continent, was not only that there might be a few “lucky” surviving benefits that might make it through the “harrowing” attacks upon that Proposal throughout its History here in America. This Proposal, made by the American People, to both the Scrutiny of the Whole World and to that of the Native American People who were the Owners of this Land, was the ultimate Business Proposal – that is, this Proposal was for a Business Success THAT HAS NOT HAPPENED TILL TODAY, but that is ready to happen, as that Business Success, today. There are details of this History that are available in the Booklet that has been mentioned. However, a brief recounting of the History of those Harrowing Attacks upon that “Title to be here” may be appreciated as an introduction to that long awaited “Business Success” that is now prepared to be realized.

The Brief History

As has been recounted, the dynamics proved to be opportune for some of the “Adventurers” who were associated with the London Fishmongers Guild’s ancient London Fishing Navy to settle the Coastline of the Grand Banks Fishery, as New England, shortly after the beginning of the Thirty Years War. However, as that War was ending and the English Civil War began, the Enemies of the Commonwealth of London’s NAVY, that won that War, fled to the Colonial South. Many of these were the deposed supporters of England’s Medieval Aristocracy’s Feudal ARMY, which lost that War. They had been the rival sides competing for Administrative Power in England’s Medieval History. They were the committed opponents of the Practices of the Commonwealth of London’s Navy, which defeated them in that War. That is, these were in large measure the deposed Feudal Aristocrats who were the avowed Enemies of the Commonwealth of London and of the Hanseatic League’s Free Enterprise System.

The bulk of the South's population was for the Royalist Cause of England during the Revolutionary War. However, as the traditional "Yeomanry" of the Townmeetings of New England drove the British Army out of North America, many Southern Feudalistic Aristocratic minds committed themselves to a war of defeating the Organizational Plan of the New Englanders, now that they had lost to them on the Field of Battle.

The Organization of the People of Colonial New England had an Achilles Heel. That was that their Organizational Culture was completely based upon the Concept that they were in possession, from the Religion of Jesus Christ, of an "Orderly Conversation" by which they could instruct anyone who wanted to know how to "do all that they do in the Good Faith of the Lord Jesus Christ" in order that they might follow the Principles of the Law Merchant, the Free Enterprise System, to the Business Success that they were being called by God to achieve for the benefit of His People – which is the Culture of the Ancient Commonwealth of London from its beginnings and as it persists as its Ancient Liberties and Free Customs till this day.

An available way to wound that Achilles Heel was through the fact that, although the Organization of the New England People was that of the Ancient Nordic Race's Free Enterprise System, the way that they schooled themselves to learn all of the Elements of their "Orderly Conversation," that operated their Organization, was through the System of Schooling that the Roman Catholic Church had introduced into England during the Middle Ages as the rationale for controlling the "land-based" (as contrasted with sea-based) operations of Medieval Roman Catholicism's Invention of "Feudalism."

The basis of Medieval Roman Catholicism's Feudalism is a Challenge from Ancient Greek Philosophy that the basic power that the Lord Jesus Christ said that he was conveying to the Human Race is impossible to be conveyed to humans.

Pointing out for the New Englanders that their "Orderly Conversation" that they were exchanging with the Indians as their Title to live here was built on this "bubble," that these Southerners were about to burst, of this inconsistency, the "General Intellectual Leadership" behind the Organization of the New England People began collapsing.

To say it in brief, the People of New England and their theretofore Intellectual Leadership were merely asked what the Lord Jesus Christ (of which only the first of those three names is Anglo-Saxon while the last two are from Ancient Greek origins) who was taught to them by Catholicism, as Roman Catholic History tells that story, ever personally had to do with their ancestral Anglo-Saxon concepts of: Law, Freedom, Rights, the Free Enterprise System, or even, for that matter, the concept that one fulfills all that one is supposed to do in that ancient Free Enterprise System of their Anglo-Saxon Forefathers by doing all that they do therein in the Good Faith of the Lord Jesus Christ. As these Intellectual Leaders, of New England's first Universities, quickly realized that these Southerners had "popped the balloon" that they had built New England on, the previous New England quickly "vanished," and Feudalistic Southerners moved into the positions of primary Social Administration among the people of the young USA rather than the New Englanders who had organized the American Revolution.

When this Balloon popped one conscientious New England child, a relative of the descendants of that Church Minister who had invented the American Republican Form of Government, went out into a Woods to pray to God to ask what it was that should be done. God the Father and His Son Jesus Christ appeared to him and told him that he would be given the Information that he wanted.

One piece of that Information that was given to him was, Doctrine and Covenants 86:8,9&11: “Therefore, thus saith the Lord unto you, with whom the priesthood hath continued through the lineage of your fathers – For ye are lawful heirs, according to the flesh, and have been hid from the world with Christ in God – Therefore, blessed are ye if ye continue in my goodness, a light unto the Gentiles, and through this priesthood, a savior unto my people, Israel.”

This Young Man, the LDS Prophet Joseph Smith, Jr., as so many of the other New Englanders who were associated with him, were the descendants of the Adventurers of that London Fishing Navy that had founded New England. Indeed, these persons were the descendants, “through the lineage of your fathers,” back through the many centuries of their employment in the London Fishmongers Guild’s Fishing Navy, of previous history, to the ancient Founders of the London Guild System. In contrast to the ignorance concerning the association of Christ with that London Guild System – with which the Feudal Aristocracy forebears of the Aristocratic Southerners had fought throughout those centuries – the Lord Jesus Christ, Himself, tells these New Englander descendants that they and their “flesh,” “the lineage of your fathers” “have been hid from the world with Christ in God.” So, though the Balloon popped that the Intellectual Leaders of the Universities of New England had been trying to use to reach New England’s “Only End,” this was the beginning of a glorious new day toward that Only End by all of the American People who really wanted, with all of their hearts, to truly “do all that they do in the Good Faith of the Lord Jesus Christ.”

“How may they truly ‘do all that they do in the Good Faith of the Lord Jesus Christ’?” The Lord tells us, “Therefore, blessed are ye if ye CONTINUE IN MY GOODNESS.” He showed the Prophet Joseph Smith, Jr. that the True Church of the Lord Jesus Christ is organized in practically the exact same way as the Christian Anglo-Saxon Founders of London organized it and the way that it has stayed so organized through the intervening centuries to this day. Moreover, Joseph Smith was instructed that the Working Males of the LDS Church are to work together, in their Law of Consecration or “United Order,” in the exact same way that the 500,000 London Free Men, who compose the London Bond Market that operates the World’s Economy today, have always been organized to work together by their Business Law, the Law Merchant.

A Southern Feudalism Sociologist, at coming upon this Information, might say, “Oh, yes, you Mormons. You are the New Englanders who decided that you were just going to keep right on trying ‘to do all that you do in the Good Faith of the Lord Jesus Christ’ just like your New England Forefathers had been trying to do as their ‘Lawful Title’ to be on the North American Continent before we Southern Thinkers popped their Balloon for them!

You New Englanders! The Purpose that we Feudalistic Southerners had in coming to this Land was, without any apology, to Murder the Family that used to live on this Land and to Steal this former Home of theirs away from them. And you New Englanders have always felt that you were so much better than us because of the difference between our Reality and your Balloon. But we have popped it. ‘Do you know what that makes you?’ It means that with that popped Balloon, if you stay here, that makes you no better than any of the rest of us, just another bunch of ‘Unapologizing Murderers of the Family that used to live here and Thieves of their Homes.’ And, if you think that you are going to get out of your Popped Balloon situation just because certain other New Englanders said that God restored the True Church to them that operates just like your ancestral London Commonwealth, I am here to tell you that you have the entirety of the Ancient Greco-Roman Intellectual Structure, that all of Medieval Feudalism is based upon, to fight you at every step that you take as you try to pursue that.

That Southern Outlook explains much that was involved in the expulsion of the LDS Church from what was predominantly a Confederate Missouri. And, the Give-up Attitude of so many other Northerners, in the face of that, then, apparently triumphant Southern Outlook, can explain much of those problems that were involved in the expulsion of the LDS Church from the USA and their necessity to seek a refuge in the Rocky Mountains, in those days a part of Mexico.

Further, the continuance of that Give-up Attitude, on the part of Northerners in the face of that Southern Challenge, even long after those Northerners had defeated the South in the US Civil War, goes far in explaining why the LDS People of Utah were not allowed to become another State in the US Union until they discontinued their United Order in what was to become the State of Utah.

For that reason, the only people on the North American Continent, who can show that they live here based on the only Lawful Title that the English-speaking People have ever given as their Title to be here, are those LDS People who settled in that part of the “Intermountain West” that remained a part of Mexico as the final States of the “Lower 48” were brought into the Union.

In 1966, the President of the LDS Church, David O. McKay, prophesied that the LDS People would develop the Key Elements of the Utility that the US Government had been hoping would be developed to enable the People of the USA to show the rest of the World how to work together with us in our ancestral Free Enterprise System. That happened, as he said that it would. The Worldwide Internet of today is the result of that. The entire World today wants to work on and with the Internet. They most earnestly want to know exactly how it works and what it is that makes it work.

When they do that and they find out how the Principles operate that allow Machines, Computers, to completely process, at a level of full understandability, all of the Thinking of all of the Human Race, expressed in all of their many Languages, they see how the Ancient Asininites of the Ancient Greco-Roman Philosophers, in their “Rules” about what could never be understood about Human Languages, are the most

worthless of guesses. That is, that basis of Medieval Aristocratic Feudalism, with which those Southern Aristocrats felt that they had popped the Balloon of the New Englanders, is itself a Balloon that itself has been popped by the Invention of the Internet. Or, said as a few-word synopsis of “the 1,000-page Course,” as the Ancient Greco-Roman Philosophers conspired to establish their ancient form of the Statecraft that they were essaying to make into the System to rule the Whole World by, they realized that they had to base it in some way upon this “Pattern” of the behavior of the minds of all Human Beings, as they are born into the World, this identical Pattern that explains the identical operation of all of the Languages of Mankind. As they pondered at what this, at that time to them seemed, inexplicable Pattern (that they named “Grammar”) could possibly mean, they came to their Consensus that this Pattern could never be scientifically understood nor explained by anybody (even though the leading Thinkers of China had effectively explained about 80% of it about 700 years earlier). Now, today, as 100% of that Explanation is available to all that want it, that wrong guess of the Ancient Greco-Roman Philosophers, that they based their version of Ancient Statecraft upon, that so cheapened so much of Life on Earth, such as the Balloon popping against the New Englanders, has been shown to have been nothing more than that, a bad guess, that itself is on the verge of being completely discarded as the whole World now comes to an understanding of the True Principles about the operation of Human Languages that the Internet functions on.
